

# TECHNICAL SPECIFICATION.

# Clause T1

This specification establishes the requirements, supply, delivery, end user training, demonstration, commission and installation of the an Oxygen enriching Air Machine, which must comprise the latest Technology and design and must be suitable for both Adult and Paediatric application.

# Clause T2

The unit being quoted for must be of a sturdy / robust construction without any sharp corners or sides that may cause injury to patients and staff.

### Clause T3

The unit being quoted for must be portable and fitted with casters / wheels in order to enable easy mobility of the unit for one area to another. The castors / wheels must preferably be equipped with brakes.

## Clause T4

The dimensions of the unit must be no more than 73cm Height X 40cm Width and 37cm Depth and its weight must be no more than 30Kg.

### Clause T5

The unit being quoted for must incorporate handles to facilitate easy movement / carrying of the machine.

### Clause T6

The air intake and exit openings must be positioned in such a manner that circulation of air is not compromised should the unit be placed against a wall.

# Clause T7

The front of the air exit must be fitted with a disposable bacterial air filter. Bidder must state the price of a replacement disposable air filter.

## Clause T8

The unit being quoted for must be fitted with a washable disposable air intake filter that could be easily removed, replaced and cleaned by the user.

# Clause T9

The unit must have an oxygen outlet nozzle that easily connects to Tubing and/or Humidifier / Nebulizer.

# The unit must be fitted with a ball type FLOWMETER as follows:

- (a) Well positioned / mounted so that it is well protected against mechanical damage.
- (b) User must be able to read from a wide angle of 140 degrees.
- (c) Controls the Oxygen flow rate and reflects the latter to an accuracy of less than 5% at the maximum portion of the flow rate range.

# Clause T11

The unit being quoted for must have a tamper proof **HOUR METER**, which must reflect the total number of operating hours of the machine.

### Clause T12

The unit must be fitted with an **ON / OFF** switch, it must be able to operate off the 220 Volt  $\pm$  10%, 40hz, single phase a.c. supply and be fused in the **LIVE** or both **LIVE** and **NEUTRAL**.

The unit must provide visible indication to indicate when the unit is switched ON.

The unit must be able to deliver minimum oxygen enriched air concentrations at different capacities as follows:

- (a) 2 Litres per minute at 95% ± 3%.
- (b) 3 Litres per minute at  $92\% \pm 3\%$ .
- (c) 4 Litres per minute at 90% + 3%.

# Clause T17

The unit must be able to reach an oxygen enriched air concentration of 90% as indicated in the above Clause within 10 minutes of switching ON.

# Clause T18

The unit being quoted for must make use of the **MOLECULAR SIEVE BED METHOD** and this must be situated preferably in two refillable cylinders where the machine will automatically rotate between the two cylinders.

## Clause T19

The unit being quoted for must have a minimum of the following alarm systems in place:

- (a) Battery powered, audible alarm that is triggered in the event of an electrical power interruption. The audible alarm must be loud enough so that even patients with impaired hearing will be woken from their sleep. Bidder must state the type of battery employed i.e. rechargeable or disposable dry cell.
- (b) An audible alarm if the concentrator air pressure rises above 35 PSIG.
- (c) An audible alarm if the concentrator air pressure drops below 4 PSIG.
- (d) An alarm if the oxygen enriched air concentration drops below 80% ± 3%.

# Clause T20

The unit being quoted for must be provided with a bacterial filter for protecting the oxygen enriched air outlet. Bidder must state how often this filter will require replacement, whether it requires Technical Personnel for replacement and also the cost of the replacement filter.

# SPECIAL CONTRACT CONDITIONS OF QUOTATIONS

#### 1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

### 2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

### 3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
  - (i) that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
- 3.4. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 3.5. This quotation will be evaluated based on the 80/20 points system, specification & correctness of information. All required documentation must be completed in full and submitted.
- 3.6. Offers must comply strictly with the specification.
- 3.7. Only offers that meet or are greater than the specification will be considered.
- 3.8. Late quotes will not be considered.

- 5.1. Quotation shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the quotation documents.
- 5.2. Each quotation shall be addressed in accordance with the directives in the quotation documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the quotation number and closing date indicated on the envelope. The envelope shall not contain documents relating to any quotation other than that shown on the envelope. If this provision is not complied with, such quotations/bids may be rejected as being invalid.
- 5.3. All quotations received in sealed envelopes with the relevant quotation numbers on the envelopes are kept unopened in safe custody until the closing time of the quotation/bids. Where, however, a quotation is received open, it shall be sealed. If it is received without a quotation/bid number on the envelope, it shall be opened, the quotation number ascertained, the envelope sealed and the quotation number written on the envelope.

## 8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

# 9. SUBMISSION AND COMPLETION OF SBD 6.1

9.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. The preferences applicable on the closing date will be utilized. Any changes after the closing date will not be considered for that particular quote.

# 10. TAX COMPLIANCE REQUIREMENTS

- 10:1. In the event that the tax compliance status has failed on CSD, it is the suppliers' responsibility to provide a SARS pin in order for the institution to validate the tax compliance status of the supplier.

### 12. PATENT RIGHTS

The supplier shall indemnify the KZN Department of Health (flear after known as the purchaser) against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

# 13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
- 13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.
- 13.4. # 14. TERMINATION FOR DEFAULT
