1.1 SCOPE OF CONTRACT

1.3 CONDITIONS OF CONTRACT AND PRELIMINARIES

1.3.1 PERIOD OF CONTRACT

Four six (04) Weeks as the Contract Period for the completion of the Work from date of Site handover.

1.3.2 CONTRACT GUARANTEE:

Damage to the existing buildings - Bidders to note that any damages done or occurring to any of the buildings will be repaired at the expense of the contractor/ Tenderer.

Minor repairs must be done to the satisfaction of the Kwa Zulu- Natal Department of Health (infrastructure).

Bidders are advised to visit the site prior to tendering and to acquaint themselves with the nature of the work to be done and access to the sitting of the existing buildings etc., as no claim whatsoever will be allowed on the grounds of ignorance of the conditions under which the work will be executed.

1.3.3 GUARANTEE PERIOD

The guarantee period for the completion of the Structure indicated above and all materials must be a minimum of <u>twelve Calendar Months</u> from the date of final delivery.

1.3.3.1 PENALTY FOR NON COMPLETION

Penalties of 5% a day shall apply for non-completion.

1.3.4 SITE AND MODE OF PROCEDURE

The work or services contained in this contract will be carried out on the site of the existing **Busingatha clinic (Pit Toilets)**

1.3.5 SATISFACTORY INSTALLATION

The whole repairs shall be carried out in accordance with the South African Bureau of Standards Code of Practice for the application of National Building Regulations, the KZNPA Standard Preambles to all Trades, the KZNPA General Specification, the South African Bureau of Standards Code of Practice and the Occupational Health and Safety Act and Regulations 85/1993 as amended.
