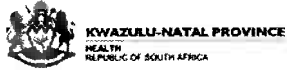

3. A tenderer (bidder) must submit Original proof of address from Ward Counsellor or Utility Bill of tenderer (bidder) not less than three months old. Or A Tenderer (Bidder) subcontracting must submit Original proof of address from Ward Counsellor or Utility Bill of tenderer (bidder) not less than three months old. Note: Tenderer (Bidder) failing either of the two criterion will be regarded as non-responsive and immediately be disqualified		
4. If the Tenderer (Bidder) opted to subcontract a minimum of 30% to an EME or QSE per above, there must be valid proof of joint venture agreement endorsed with South African Police (SAPS) affidavit. Note. We reserve the right to check for validity of the joint venture agreement. Tenderer (Bidder) sub-contracting but failing this criteria will be regarded as non-responsive and will immediately be disqualified		
5. The EME and QSE subcontracted must be registered with Central Supplier Database (CSD), have valid tax clearance certificate on Central Supplier Database (CSD). If expired there must be proof of tax clearance certificate which will be checked and verified with SARS via pin number.
