#### 5.1. TECHNICAL SPECIFICATION

#### 5.1.1 GENERAL

This Technical Specification shall be read in conjunction with all other sections of the Specification and cognisance shall be taken of the clauses relevant to this particular installation, whether any specific clauses are referred to or not.

#### 5.1.2 GENERAL REQUIREMENTS

Tenderers are to make special note of the following:

This particular specification must be read with, and shall form part of, Part 4 of this document (Technical Specification).

In so far as the conditions contained herein are at variance with any obtained in the Technical Specifications, the contract shall be interpreted in terms of this Part 5 (Particular Specification).

The whole installation shall be in accordance with the Occupational Health and Safety Act 85/1993 and all regulations framed therein shall be carried out to the satisfaction of the Department of Health.

Competent workmen skilled in their trade shall carry out all work. Quality shall be of the best standard practice and all workmanship will be subject to the approval of the Department of Health.

The work shall at all times, for the duration of the contract, be carried out under the supervision of a skilled and competent representative of the Contractor, who will be able and authorized to receive and carry out instructions on behalf of the Contractor. A sufficient number of workmen shall be employed at all times to ensure satisfactory progress of the work.

All apparatus, component parts, fittings and materials employed in the execution of the Contract shall be new and unused and shall be the latest type or pattern of the particular manufacture employed. S.A.B.S. mark bearing items shall be used wherever possible.

The installation shall be maintained for a period of twelve months after acceptance in writing by the Department of Health and shall allow for routine inspections not less than two times a year.

The complete installation must be guaranteed against defective parts and workmanship for a period of twelve months after the date of issue of the Completion Certificate. This period shall run concurrently with the maintenance period.

Rates are to include for commissioning and testing of the complete installation and handing over in working order ready for use.

Tenderers are advised to visit the site and acquaint themselves fully with the site conditions and nature and full extent of work involved prior to submitting their tender. Claims on the grounds of insufficient information in such respects or otherwise will not be entertained by the Administration.

#### 5.2 SCOPE OF CONTRACT;

#### **5.2.1** The specification calls for:

- The supply and installation of new electric geyser.
- The complete new installation shall be tested and handed over in complete working order ready for use with subsequent maintenance and guarantee.

#### 5 THE SITE

The site is at Dundee forensic mortuary, 121 MacKenzie Street, Dundee.

#### 5.4 PROGRAM OF WORKS

It is imperative that the installation be achieved without any unscheduled interruption of water and power to other parts of the mortuary. The mortuary therefore minimum downtime is crucial and shall be carefully planned prior to connecting and commissioning into the existing power supply.

Throughout the duration of the works, the works are to be planned and executed to cause minimum inconvenience to all staff.

#### 5.5 INSTALLATION DETAILS.

#### **DESCRIPTION OF WORK**

- One existing geyser shall be disconnected, removed from its position.
- One 200 L copper geyser shall replace the disconnected geyser.
- The geyser shall be connected to the existing power supply.
- Maintenance and guarantee: The geyser and associated equipment shall be tested, commissioned, ready for use and guaranteed for 12 months. (on top of manufacture's guarantee

#### 5.6 GEYSER

One new copper geyser shall be installed with associated equipment as detailed below.

#### **NEW COPPER GEYSER**

The geyser shall be of copper material with 3 KW electric loading and an operating pressure of 400 KPa.

The geyser shall be of the "Tecron" or range or other approved electric type (sustainable.co.za)

#### 5.8 PROGRAM OF WORKS

The contractor shall notify the Department of Health seven (7) days prior to carrying out any site work. As the Centre is to remain in full operation for the duration of the works, the works are to be planned and executed so as to cause minimum inconvenience to staff.

#### 5.9 TESTING AND COMMISSIONING

The units shall be tested and commissioned before handing over to the mortuary. The Department of health Engineer/project leader shall witness the test.

#### 5.10 MAINTENANCE MANUALS

Two sets of maintenance and operating manuals are required, which shall include all diagrams, spare parts lists, operating instructions, etc.

#### 5.11 MAINTENANCE AND SERVICING

The unit is subject to an unrestricted twelve (12) month free guarantee period, after the date of issue of the Completion Certificate. This is to cover all aspects of the equipment associated with wiring, controls etc. A 12 months' service contract must be in place to perform preventative maintenance thereafter.
