SPECIFICATION FOR THE REQUIRED RESIDENTIAL ACCOMMODATION

Request the Departmental Supply Chain Management (SCM) to procure fully furnished residential accommodation for Cuban Doctors reporting at General Justice Gizenga Mpanza Regional Hospital.

The minimum specification for furniture requirements are as follows:

BEDROOMS:

- 1. Bedroom of a minimum size of $3.5 \text{m} \times 3.5 \text{m} = 12.25 \text{m}^2$
- 2. One double bed (Must be able to take 70 Kg per person)
- 3. Wardrobe/built in cupboards (With water resistance material)
