## **SUPPLEMENTARY PREAMBLES**

The contractor must visit the site and acquaint himself fully with conditions and scope of alterations. Descriptions herein are brief and are to serve as a means of identifying work only. The full extent of work is to be assessed by the contractor on site.

Old materials from alterations, except where described to be re- used or handed over, as well as rubbish, etc. must be regularly carted from site and not be allowed to accumulate on or around the site.

### **SCOPE OF WORK**

To install electrical meter 3Phase (Kwh) with CT connectors and water meter.

### **ELECTRICAL**

Supply, deliver and install electrical meter 3Phase (Kwh) with CT connectors. Electrical meter to be installed on electrical supply from sub-station. **NB. COC** must be provided.

#### **PLUMBING**

Supply, deliver and install water meter. Water meter to be installed in water supply line.

ALL WORKMANSHIP MUST BE OF HIGH QUALITY AND ALL MATERIAL USED MUST BE SABS APPROVED AND HIGH QUALITY.
