

Test, identify and report on non-functional dock loaders

**Part B**

**Service functional dock loaders**

The following scope of work will be carried out by a qualified Service Technician.

**DECK AND FRAME**

1. Inspect deck
2. Inspect lip and hinges
3. Inspect deck hinges
4. Lubricate lip hinges
5. Lubricate deck hinges
6. Inspect deck support beams
7. Inspect pneumatic cylinders & gravity arm
8. Inspect and tighten fittings
9. Test max height limit
10. Test lip limit
11. Clean pit off all debris
12. Ensure that deck does not touch sides of the pit
13. Check all hydraulic cylinders and seals if applicable

NB. This scope must include all consumables and sundry items as required for this job.

Requirements for a qualified contractor:

- Contractor must have mechanical or fitter trade test, CIBD registration (1ME or more), with experience
- The above requirements will be verified when the contractor gets to site before they start working.
