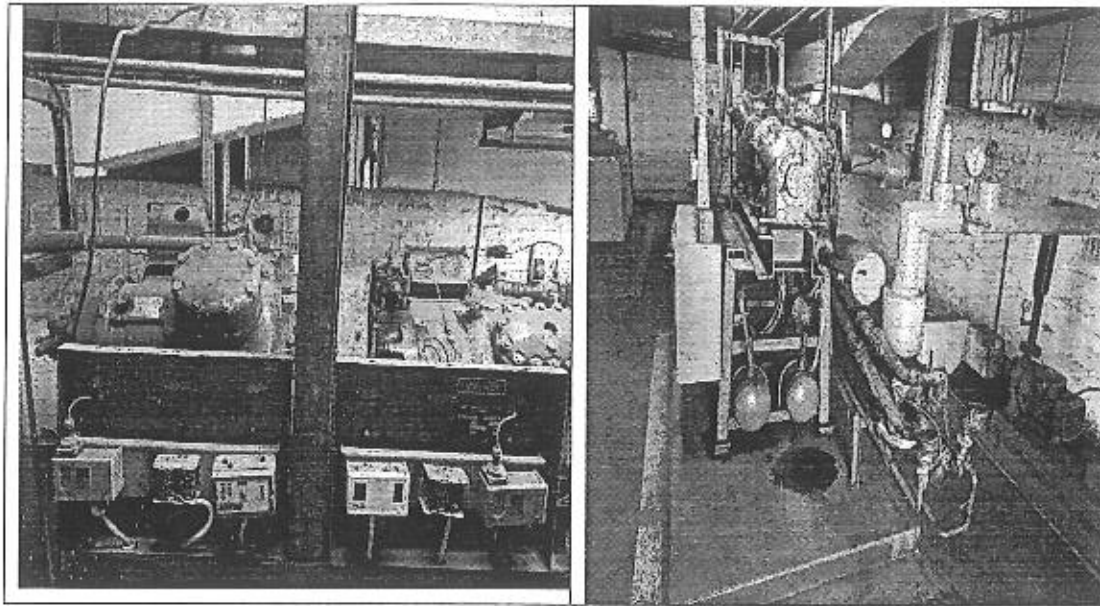

MEDICAL PHYSICS PLANT ROOM: CHILLER MODEL NO: PC30.24



System Description:

This chiller consists of 2x open types compressors, 2x shell and tubes condensers 1x shell and tube evaporator with 2x circuits, 1x condenser pump, 1x chilled water pump, and 2x AHU's. upon our investigation we discovered that shell and tube evaporator is leaking water in 1 circuit, the other circuit is working fine, but this shell and tube must be replaced because of water and gas mixing inside the shell and tube, currently the chiller can run on 1 circuit provided the condenser pump is fixed. We also noted wiring for condenser pumps and cooling tower fan motor must be replaced, 2x 380V isolators 3 pole 32amp water proofing must be replaced. There will be more report on the associated equipment shown on page 3 & 4.

Scope:

- Rig out compressor for repairs
- Replace shell and tube evaporator as per the attached pictures
- Replace 60m of 6mm 4 core plus earth cable to wire the pump and cooling tower fan motor
- Allow 10 lengths cable tray to suit 6mm cable
- Replace 2x 32A 3 pole isolators
- Replace AHU fan assembly EMB type model number DWRG22 Z/5S, 1,3kw 1370RPM.
- During replacement of fan above duct insulation will be removed please replace accordingly
- Allow 3 cylinders of R22
- Allow 11kg of nitrogen to flush water on piping
- Evacuate system up to 500 micron
- Replace fresh air ducting 650 x 650 x 5m galvanised sheet metal
- Replace transformation piece to whether louver 650 x 650 x 1,4m as it shown on pictures none insulated
- Rod 2 shell and tubes condensers

- Allow for oil analysis in 1 system
- Allow chilled water insulation on 68mm pipe x 2m 25mm thick next to AHU and water valve as it is shown in the picture above
- Lift up coil with proper rigging equipment and slide the new drip tray 520 x 1,6M X60mm depth
- Remove condenser pump for repairs (replace seals bearing)
- Rewind 3kw 380V motor and replace bearings (and renew switch gear)
- Replace 24V actuator as per model on picture
- Replace chilled water make up tank 316 stainless steel 700mm x 700mm x 550 x 5/6mm thick.
- Replace chiller water sensor
- Replace Flow switch
- Allow for fittings as it shown on pictures and use existing if necessary.

Please note flushing should be done when compressor and evaporator shell and tubes are out, and accordingly to HVAC standards plant room should be clean at all times and at this stage it is not in good state.



- Replace fan assembly EBN type model DWRG22 Z/5S, 1,3kw 1370RPM.



The above evaporator shell and tube is leaking and mixing gas with water as it said on above it must be replaced and commissioned.

- Replace bearings on pump
- Replace seals
- Replace rubber coupler
- Tapper lock
- Commission and note flow rate

1. AMENDMENT OF CONTRACT

- 1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

- 2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (*domicilium citandi et executandi*) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:

- 8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

12. PATENT RIGHTS

The supplier shall indemnify the KZN Department of Health (here after known as the purchaser) against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2.
