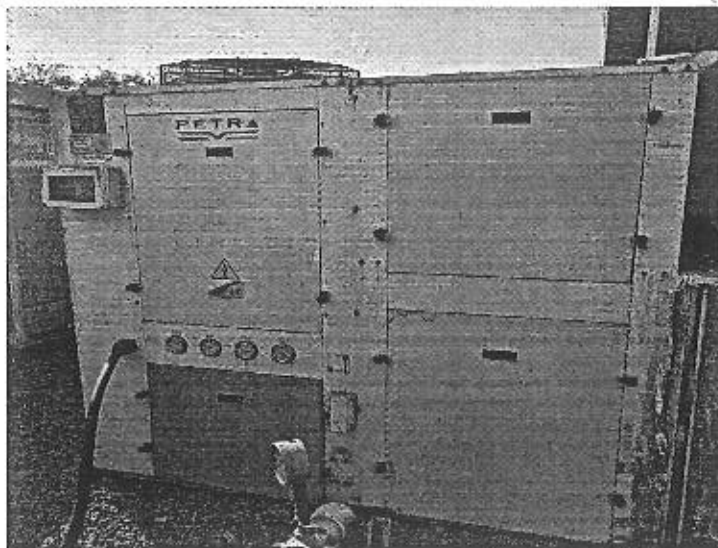
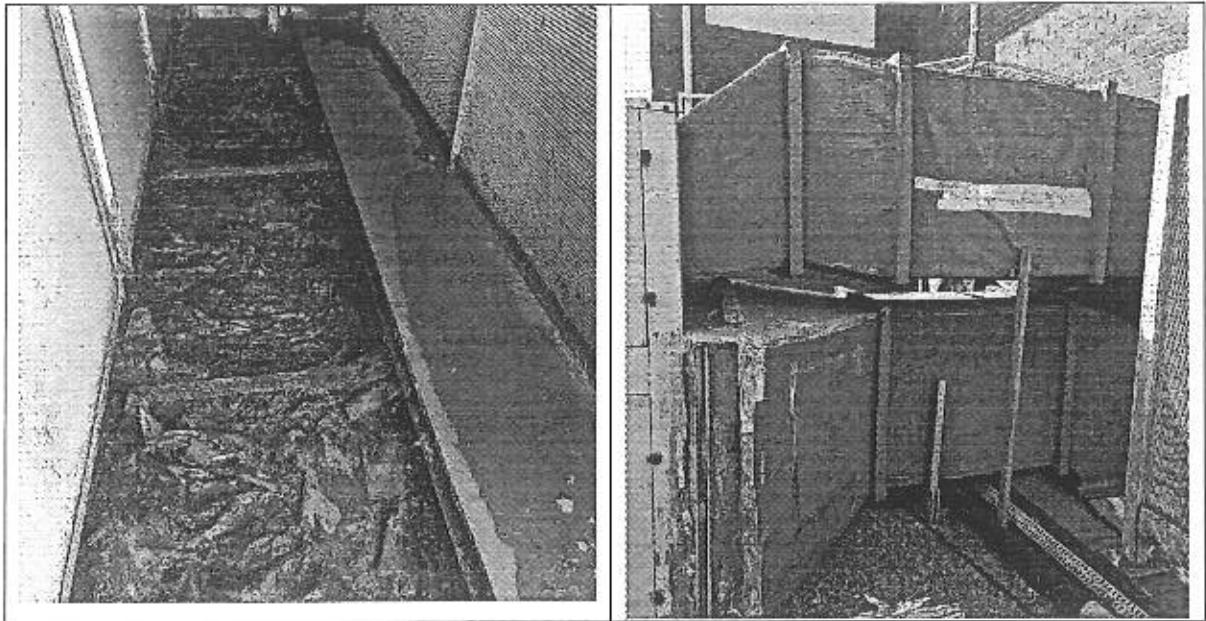

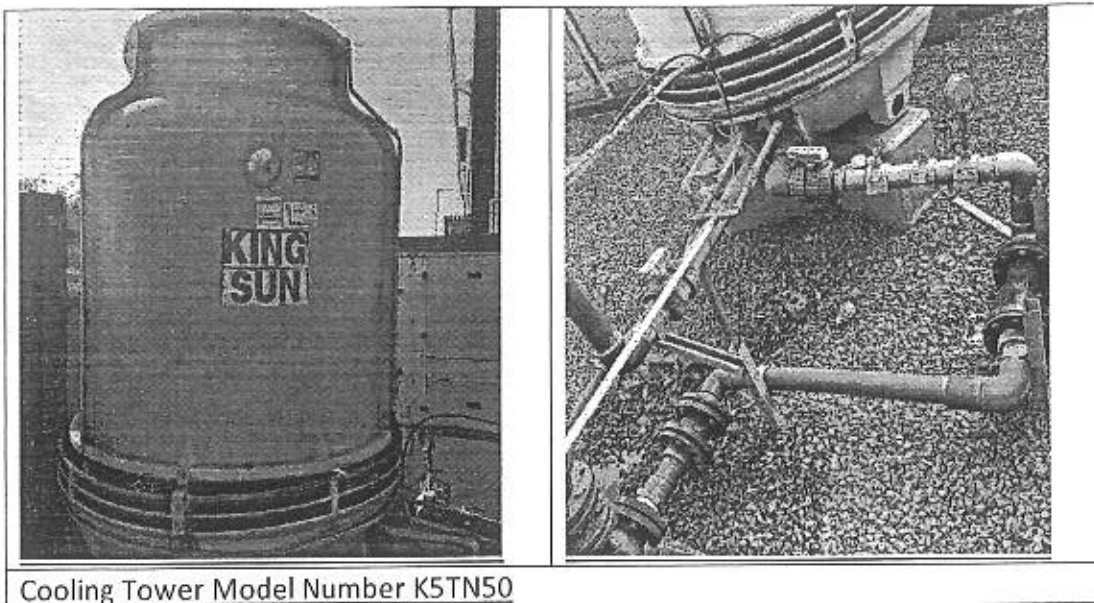


Carried out an assessment on rooftop packaged unit in room 50, this system runs on R22 gas with 2x circuits and each circuit has 1 scroll compressor tested circuit 2 compressor and discovered that the compressor is faulty. It must be removed and replaced with new ZR 144 KCE-155 compressor. Insulation must be replaced as it shown above on top left. The supply and return air duct on top right picture they require internally and externally insulation of 20mm internally insulation and 40mm externally polystyrene cladded with membrane and water proofing.

Scope:

- Replace system 2 ZR144 KCE – 155 scroll compressor R22 380v
- Replace liquid line drier 5/8 sweat
- Replace 1 x 32A contactor and overload
- Duct insulation supply air 39.85 m²

1x KING SUN COOLING TOWER FOR ROOM I4A & I4B



Upon our investigation on the above cooling tower system, we discovered that the cooling tower is losing a lot of water through water circulating pump. We also noticed that when the pump is running, water does not circulate which is caused by blockage of inline strainer as well as shell and tube condenser which are located inside the water cooled packaged units, this must be rectified.

The following components must be replaced in order to bring the cooling tower at state it used to be:

- Replace 80mm union (PVC)
- Replace 3x 80mm shut off valves (PVC)
- Allow 4x gaskets for 80mm table and flange
- Allow 2x lengths of 80mm PVC pipes class 12
- Replace cooling tower fan circulating thermostat similar with the existing or equivalent will be acceptable.
- Remove closed coupled pump for bearing and seals replacement, bearings must be 5kw or equivalent. Paint motor with metallic blue paint to match existing.
- It is recommended to have tap next to cooling towers in order to pressure clean the equipment, allow 1 x ½ inch plastic tap with accessories, use the cooling tower main supply feed.
- Allow 5x 80mm elbows and 3x couplings 80mm
- 1 ½ litre
- Re-do piping configuration on suction side from cooling tower 3m using the allowed above 2 lengths of pipe class 12.

1. AMENDMENT OF CONTRACT

- 1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

- 2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (*domicilium citandi et executandi*) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
- (i) *that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk*

- 8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

9. SUBMISSION AND COMPLETION OF SBD 6.1

- 9.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. 13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
