There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

4.10. The Department is under no obligation to pay suppliers in part for work done if the supplier can no longer fulfill their obligation.

5. SPECIAL INSTRUCTIONS REGARDING HAND DELIVERED QUOTATIONS

- 5.1. Quotation shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the quotation documents.
- 5.2. Each quotation shall be addressed in accordance with the directives in the quotation documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the quotation number and closing date indicated on the envelope. The envelope shall not contain documents relating to any quotation other than that shown on the envelope. If this provision is not complied with, such quotations/bids may be rejected as being invalid.
- 5.3. All quotations received in sealed envelopes with the relevant quotation numbers on the envelopes are kept unopened in safe custody until the closing time of the quotation/bids. Where, however, a quotation is received open, it shall be sealed. If it is received without a quotation/bid number on the envelope, it shall be opened, the quotation number ascertained, the envelope sealed and the quotation number written on the envelope.
- 5.4. A specific box is provided for the receipt of quotations, and no quotation found in any other box or elsewhere subsequent to the closing date and time of quotation will be considered.
- 5.5. No quotation/bid sent through the post will be considered if it is received after the closing date and time stipulated in the quotation documentation, and proof of posting will not be accepted as proof of delivery.
- 5.6. Quotation documents must not be included in packages containing samples. Such quotations may be rejected as being invalid.

6. SAMPLES

- 6.1. In the case of the quote document stipulating that samples are required, the supplier will be informed in due course when samples should be provided to the institution. (This decreases the time of safety and storage risk that may be incurred by the respective institution). The bidders sample will be retained if such bidder wins the contract.
 - (i) If a company/s who has not won the quote requires their samples, they must advise the institution in writing of such.
 - (ii) If samples are not collected within three months of close of quote the institution reserves the right to dispose of them at their discretion.

1.6 The purchaser reserves the right to require of a bidder, either before a quote is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

RE-JACKING OF PARK-HOMES AT VARIOUS EMS FACILITIES

SCOPE OF WORK

This Quotation calls for the Re-jacking of Park-home Offices at the following EMS facilities:

- 1) 2 x 5-Office Park-homes at the EMS District Office which is situated in Ladysmith
- 2) 1 x 3-Office Park-home at the Bergville EMS Base which is situated in Bergville
- 3) 1 x 3-Office Park-home at the Emmaus EMS Base which is situated at Emmaus Hospital
- 4) 1 x 3-Office Park-home at the Oliviershoek EMS Base which is situated at Oliviershoek Clinic.
- 5) 1 x 3-Office Park-home at the Ntabamhlope EMS Base which is situated at Ntabamhlope Clinic.

SPECIFICATION

Remove the skirting from around the base of the Park-home and loosen the tie down straps. Determine the extent to which the respective Park-home has sunken. Re-jack and level the Park-home by following steps:

- 1) **Checking the level** - Begin at the centre of the Park-home. Place an appropriately long spirit level at the centre of the beam. Check the level near the closest support under the Park-home. Check the spirit level to see if the bubble in it is resting in the centre. If it is, move the level down the beam to the area near the next support. Check the bubble to see if the next area is level. Continue to the end of the beam. When a length of the beam has been checked from the centre to the end, return to the centre of the beam to check the level of the other end of the Park-home. Ensure that the spirit level is placed near the supports.
- 2) **Raising the beam** – If the spirit level indicates that there is part of the Park-home that is not sitting level, use the jack to raise it to the necessary height. Place a piece of wood under the jack to support it. Raise the jack until the bubble in the spirit level rests in the centre. There will be a space between the support for the beam and the beam itself.
- 3) **Using shims** – Slide the shims into the space between the support and the beam. If necessary, use a hammer to secure the shim. Lower the jack so that the beam rests on the shims. Check the bubble in the level again. Continue this process in any areas along the beam where the bubble in the level does not sit in the middle.
- 4) **Checking the plumbing and water lines** – Ensure that none of the sewer or water piping is damaged during the process of jacking and levelling of the Park-home.
- 5) **Installing the skirting** – tighten the straps and reattach the skirting around the Park-home.
