The Department is under no obligation to accept the lowest or any quote.

The Department reserves the right to communicate in writing with vendors in cases where information is incomplete or where there are 3.1. obscurities regarding technical aspects of the offer, to obtain confirmation of prices or preference claims in cases where it is evident that 3.2. a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the sapply/service

### SUBMISSION AND COMPLETION OF SBD 6.1

Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. ## 10. TAX COMPLIANCE REQUIREMENTS

13.1. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return
