

1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- The Department is under no obligation to accept the lowest or any quote.
- 3.2. The Department reserves the right to communicate in writing with vendors in cases where information is incomplete or where there are obscurities regarding technical aspects of the offer, to obtain confirmation of prices or preference claims in cases where it is evident that a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the supply/service satisfactorily.
- 3.3. ALL DECÍSIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OR CANCELLATION OF THIS QUOTATION.
- 3.4. The price guoted must include VAT (if VAT vendor).
- 3.5. Should a bidder become a VAT vendor after award or during the implementation of a contract, they may not request the VAT percentage from the Department as the service provider made an offer during the period they were not registered as a VAT vendor. The Department is only liable for any VAT from registered VAT vendors as originally stated on the quotation document.
- 3.6. The bidder must ensure the correctness & validity of the quotation:
 - (i) that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
 - (ii) it is the responsibility of the bidder to confirm receipt of their quotation and to keep proof thereof.
- 3.7. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 3.8. This quotation will be evaluated based on the 80/20 points system, specification, correctness of information and/or functionality criteria.

- 3.9. Offers must comply strictly with the specification.

- 4.1. Unless inconsistent with or expressly indicated otherwise by the context, the singular shall include the plural and vice versa and with words importing the masculine gender shall include the feminine and the neuter.
- 4.2. Under no circumstances whatsoever may the quotation/bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
- 4.3. The bidder is advised to check the number of pages and to satisfy himself that none are missing or duplicated.
- 4.4. Quotations submitted must be complete in all respects. - 5.1. Quotation shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the quotation documents.
- 5.2. Each quotation shall be addressed in accordance with the directives in the quotation documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the quotation number and closing date indicated on the envelope. 8. STATEMENT OF SUPPLIES AND SERVICES

The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

9. SUBMISSION AND COMPLETION OF SBD 6.1

Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. The preferences applicable on the closing date will be utilized. Any changes after the closing date will not be considered for that particular quote.

10. TAX COMPLIANCE REQUIREMENTS

- In the event that the tax compliance status has failed on CSD, it is the suppliers' responsibility to provide a SARS pin in order for the institution to validate the tax compliance status of the supplier.

12. PATENT RIGHTS

The supplier shall indemnify the **KZN Department of Health** (hereafter known as the purchaser) against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
- 13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.
- 13.4. If the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance.

14. TERMINATION FOR DEFAULT

- 14.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- (i) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract,
- (ii) if the supplier fails to perform any other obligation(s) under the contract; or
- (iii) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 14.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services.

Staffing and organizational structure

The contractor shall ensure that the competent and trained personnel are engaged on this contract.

Functions

The contractor shall ensure that the job purpose, key performance areas, duties and responsibilities are covered in all aspects of this contract.

Uniforms and Personnel protective equipment

All employees engaged by a contractor under this contract are to be issued with uniforms to the approval of Department of Health. The contractor shall ensure that all employees engaged on this contract are of a neat and tidy appearance. All employees engaged by the contractor under this contract must be issued with a full set of personnel protective wear. The contractor shall comply with occupational health and safety act and shall

maintain a register of all issues of personnel protective responsibilities for each staff member, which shall be open for inspection.

Provision and supply of equipment, material and labourers

The contractor shall be responsible for the supply of all equipment, cleaning material, detergents etc. In this regards the contractor shall ensure that where available only environmentally friendly chemical, cleaning material and detergents are used. The contractor shall ensure that all equipment and material used on this contract are used in accordance with the approved manufacturer's specification.

Labour

The tendered rate shall include for the provision of 3 cleaners per day Monday to Friday and 1 (one) cleaner Saturday, Sunday and Public Holidays and the performance of cleaning function for the duration of the contract as specified in the provision of services. The unit of measurement will per hour.

1. LAWNS:

- a) lawns to be kept free of weeds.
 Lawns/grass patches to be cut twice a week in the summer months.
 Lawns/grass patches to be weeded once a month. Weeds to be dug out by their roots prior to the mowing of the grass.
- b) Lawns to be kept at a length as stipulated by Centre Management.

c) All edges to be kept cut/trimmed and uniform. A spade or other instrument may be used when edging lawns.

2. FLOWER BEDS AND SHRUBS:

- a) These are to be kept free of weeds, grass and litter.
- b) Borders to be trimmed and kept neat.
- c) Water as and when required.

N.B: Soil must not be mounded around shrubs.

d) Flower/shrubs beds – soil to be turned twice a month.

3. TREES:

- a) To be kept neat and all old or dead branches to be removed.
- b) All areas surrounding the trees to be kept free of leaves.
- c) Branches where they constitute a danger to the public/department staff must eb kept above eye level.

4.VERGES:

All verges (unless excluded) surrounding the institution to be kept clean and neat.

5. CONCRETE, TARRED, PAVED AREAS: (ROADS, PARKING AREAS ETC.)

- a) To be kept clean by regular sweeping.
- b) To be kept free of weeds, grass and small trees by means of spraying with suitable weed killer.

6. GULLEYS, DRAINS AND CHANNELS:

These are to be kept clean, free of leaves, grass and general litter.

- N.B: No personnel shall be allowed to walk on roofs of any nature.
- 7. All garden refuse to be removed from site on a weekly basis.
- 8. During the relevant dormant or low growth periods, all areas are to be kept free of leaves and to be raked when necessary.
- 9. During the contract, the Contractor is to allow for the poisoning of all weeds and foreign grasses. Only the growth of recognized grasses is to be encouraged. The Contractor is to supply all the necessary poisons.

- **N.B:** Any poisons used must not be harmful to the soil, bird life, insect life and not kill off the existing grasses.
- 10. The planting of additional grass will not form part of the contract. It must first be discussed with the Contact Person at the Institution and, if necessary, a separate order will be issued for the planting of grass.
