GENERAL CONDITIONS OF CONTRACT

1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The Department is under no obligation to accept the lowest or any quote.
- 3.2. The Department reserves the right to communicate in writing with vendors in cases where information is incomplete or where there are obscurities regarding technical aspects of the offer, to obtain confirmation of prices, in cases where it is evident that a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the supply/service satisfactorily.
- 3.3. ALL DECISIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OR CANCELLATION OF THIS QUOTATION.
- 3.4. The price quoted must include VAT (if VAT vendor).
- 3.5. Should a bidder become a VAT vendor after award or during the implementation of a contract, they may not request the VAT percentage from the Department as the service provider made an offer during the period they were not registered as a VAT vendor. The Department is only liable for any VAT from registered VAT vendors as originally stated on the quotation document.
- 3.6. The bidder must ensure the correctness & validity of the quotation:
 - (i) that the price(s), rate(s) quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
 - (ii) it is the responsibility of the bidder to confirm receipt of their quotation and to keep proof thereof.
- 3.7. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 3.8. This quotation will be evaluated based on the, specification, correctness of information and/or functionality criteria. All required documentation must be completed in full and submitted.
- 3.9. Offers must comply strictly with the specification.
- 3.10. Only offers that meet or are greater than the specification will be considered.
- 3.11. Late offers will not be considered.
- 3.12. Expired product/s will not be accepted. All products supplied must be valid for a minimum period of six months.
- 3.13. Used/ second-hand products will not be accepted.
- 3.14. A bidder not registered on the Central Suppliers Database or whose verification has failed will not be considered.
- 3.15. All delivery costs must be included in the quoted price for delivery at the prescribed destination.
- 3.16. Only firm prices will be accepted. Such prices must remain firm for the contract period. Non-firm prices (including rates of exchange variations) will not be considered.
- 3.17. In cases where different delivery points influence the pricing, a separate pricing schedule must be submitted for each delivery point.
- 3.18. In the event of a bidder having multiple quotes, only the cheapest according to specification will be considered.
- 3.19. Verification will be conducted to identify if bidders have multiple companies and are cover-quoting for this bid.
- 3.20. In such instances, the Department reserves the right to immediately disqualify such bidders as cover-quoting is an offence that represents both corruption and acquisition fraud.

4. SPECIAL INSTRUCTIONS AND NOTICES TO BIDDERS REGARDING THE COMPLETION OF THIS QUOTATION.

- 4.1. Unless inconsistent with or expressly indicated otherwise by the context, the singular shall include the plural and vice versa and with words importing the masculine gender shall include the feminine and the neuter.
- 4.2. Under no circumstances whatsoever may the quotation/bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
- 4.3. The bidder is advised to check the number of pages and to satisfy himself that none are missing or duplicated.
- 4.4. Quotations submitted must be complete in all respects. However, where it is identified that information in a bidder's response, which does not affect the price, is incomplete in any respect, the said supplier meets all specification requirements and offers the lowest price, the Department reserves the right to request the bidder to complete/ submit such information.
- 4.5. Any alteration made by the bidder must be initialled; failure to do so may render the response invalid.
- 4.6. Use of correcting fluid is prohibited and may render the response invalid.
- 4.7. Quotations will be opened in public as soon as practicable after the closing time of quotation.
- 4.8. Where practical, prices are made public at the time of opening quotations.
- 4.9. If it is desired to make more than one offer against any individual item, such offers should be given on a photocopy of the page in question. Clear indication thereof must be stated on the schedules attached.
- 4.10. The Department is under no obligation to pay suppliers in part for work done if the supplier can no longer for fulfil their obligation.



5. SPECIAL INSTRUCTIONS REGARDING HAND DELIVERED QUOTATIONS

- 5.1. Quotation shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the quotation documents.
- 5.2. Each quotation shall be addressed in accordance with the directives in the quotation documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the quotation number and closing date indicated on the envelope. The envelope shall not contain documents relating to any quotation other than that shown on the envelope. If this provision is not complied with, such quotations/bids may be rejected as being invalid.
- 5.3. All quotations received in sealed envelopes with the relevant quotation numbers on the envelopes are kept unopened in safe custody until the closing time of the quotation/bids. Where, however, a quotation is received open, it shall be sealed. If it is received without a quotation/bid number on the envelope, it shall be opened, the quotation number ascertained, the envelope sealed and the quotation number written on the envelope.
- 5.4. A specific box is provided for the receipt of quotations, and no quotation found in any other box or elsewhere subsequent to the closing date and time of quotation will be considered.
- 5.5. No quotation/bid sent through the post will be considered if it is received after the closing date and time stipulated in the quotation documentation, and proof of posting will not be accepted as proof of delivery.
- 5.6. Quotation documents must not be included in packages containing samples. Such quotations may be rejected as being invalid.

6. SAMPLES

- 6.1. In the case of the quote document stipulating that samples are required, the supplier will be informed in due course when samples should be provided to the institution. (This decreases the time of safety and storage risk that may be incurred by the respective institution). The bidders sample will be retained if such bidder wins the contract.
- If a company/s who has not won the quote requires their samples, they must advise the institution in writing of such.
- (ii) If samples are not collected within two months of close of quote the institution reserves the right to dispose of them at their discretion.
- 6.2. Samples must be made available when requested in writing or if stipulated on the document.
- If a Bidder fails to provide a sample of their product on offer for scrutiny against the set specification when requested, their offer will be rejected. All testing will be for the account of the bidder.

8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

9. TAX COMPLIANCE REQUIREMENTS

- 9.1. In the event that the tax compliance status has failed on CSD, it is the suppliers' responsibility to provide a SARS pin in order for the institution to validate the tax compliance status of the supplier.
- 9.2. In the event that the institution cannot validate the suppliers' tax clearance on SARS as well as the Central Suppliers Database, the quote will not be considered and passed over as non-compliant according to National Treasury Instruction Note 4 (a) 2016/17.

10. TAX INVOICE

- 10.1. A tax invoice shall be in the currency of the Republic of South Africa and shall contain the following particulars:
- (i) the name, address and registration number of the supplier;
- (ii) the name and address of the recipient;
- (iii) an individual serialized number and the date upon which the tax invoice is issued:
- (iv) a description and quantity or volume of the goods or services supplied;
- (v) the official department order number issued to the supplier;
- (vi) the value of the supply, the amount of tax charged;
- (vii) the words tax invoice in a prominent place.

11. PATENT RIGHTS

The supplier shall indemnify the KZN Department of Health (hereafter known as the purchaser) against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

12. PENALTIES

- 12.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 12.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
- 12.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.
- 12.4. If the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance.

13. TERMINATION FOR DEFAULT

- 13.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- (i) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract,
- (ii) if the supplier fails to perform any other obligation(s) under the contract; or
- (iii) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 13.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services.
- 13.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

SPECIFICATION FOR MAINTENANCE OF GARDEN & GROUNDS SERVICE FOR KING EDWARD VIII HOSPITAL FOR THE PERIOD OF 6 MONTHS

1. SCOPE OF WORK FOR MAINTENANCE OF GARDEN & GROUNDS

1.1 Lawns:

- a. Lawns to be kept free of weeds
 - (Lawn / grass patches to be cut once a week in the summer months)
- b. Lawns to be kept at the length as stipulated by the client
- c. All edges of lawns to be trimmed & uniform

1.2 Flower Beds & Shrubs

- a. These are to be kept free of weeds, grass & litter
- b. Borders to be trimmed & kept neat
- c. Flower/ shrub beds to be turned once a month

1.3 Trees

- All dead branches to be removed that are two meters from ground level.
- b. All areas surrounding the trees to be kept free of leaves.
- Branches where they constitute a danger to the public/department staff must be kept above eye level.
- d. Leaves from tress must not be allowed to accumulate. Rake and remove.

1.4 Hedges

a. To be kept cut at a uniform height.

1.5 Concrete, Tarred, Paved Areas: (Roads, Parking Areas)

- a. To be swept & kept clean
- To be kept free of weeds and grass by means of spraying with suitable weed killer (including the external of the hospital)

1.6 Gulleys, Drains & Gutters

- a. These are to be kept clean, free of leaves, soil, grass & general litter
 - NB: No personnel shall be allowed to walk on roofs of any nature.
- b. All garden refuse to be removed from site on a weekly basis.

1.7 Working Equipment, Uniform

- c. The equipment used by the groundsmen shall be kept in a safe condition, and the use of such shall not prejudice the health & safety of the staff, patients and the general public.
- d. The contractor is responsible for providing all his/her own equipment, materials, consumables & etc.(contractor to list all the working equipment s/he shall use in maintaining the facility's garden & grounds)
- e. The contractor shall provide all its staff with the same working uniform (company's name must be written on the uniform), safety boots & name tags which must be worn all the time when performing duties of maintaining garden & grounds,

1.8 Hours of Attendance, Personnel Required & Days of the Week

- The facility requires 15 groundsmen to be on site Monday to Friday, to cover an eight hour shift.
- b. Start times and knock off time to be discussed once a contractor has been awarded with the work (i.e. have personnel which can start @ 6H00am to 14H00pm and the rest of the personnel from 07H00 to 15H30).

1.9 Supervision/Monitoring of Services

- There must be an onsite supervisor/team leader to monitor the groundsmen work on a daily basis.
- b. Monitoring of service shall be done by the contractor on a weekly basis to monitor the performance of the contract it is very important that the contractor reports to auxiliary services department before monitoring the performance of the groundsmen.
- c. The contractor shall be expected to write in the log book whenever s/he visits the site.
- d. The contractor shall report to the Assistant Director: Facilities Management to resolve any issues

- e. There shall be monthly meetings to be chaired by the Deputy Director: Facilities Management
- f. The auxiliary services' assistant director and supervisor shall at any time check the service rendered by the contractor, in order to ensure that work is performed accordingly.

2. KEY RESPONSIBILITIES FOR THE GROUNDSMAN

- 2.1 adhere to health and safety protocols with regards to the use of machinery and garden tools
- 2.2 The groundsman must all times be neatly dressed in a working uniform and wear ID badges.
 The name of the company must be printed on the uniform.
- 2.3 The groundsman must all times be respectful toward patients, hospital staff and hospital stakeholders
- 2.4 To lift /move hospital equipment from various locations within the institution.
- 2.5 No staff to participate in any strike action within the institution.
- 2.6 Shall not read office documents or rummage through office/kitchen waste

3. ADDITIONAL REQUIREMENTS

- 3.1 The service provider must provide all the groundsmen with uniforms, safety shoes and ID badges.
- 3.2 The groundsmen must be appropriately dressed all the times and ensure that they display their ID badges all the time. The name of the company must be printed on their uniforms.
- 3.3 The groundsmen must at all times be courteous and polite to staff, patients, visitors, doctors, etc.
- 3.4 The groundsmen shall be allocated to work all the garden &grounds which belongs to King Edward VIII Hospital i.e. DQ, The CEO's official house, the hospital
- 3.5 The contractor must arrange at own cost relievers for biological breaks, annual leave and absenteeism.
- 3.6 The service provider shall provide in service training to its employees to ensure that good quality service is provided and maintained (proof of training shall be requested)
- 3.7 The required number of staff must be on duty at all times as per the stated operating hours for the service provider.
- 3.8 The service provider shall pay the groundsmen the hourly rate accordingly.
- 3.9 The service provider will be requested to submit payroll document so as to monitor that the groundsmen are paid accordingly.

- 3.10 Should the service provider not pay employees accordingly the facility shall terminate the contract.
- 3.11 A valid certificate of compliance must be submitted with your quotation. Failure to do so may result in the cancellation of the bid.
