1.1. The Department is under no obligation to accept the lowest offer.

- 1.7. The Department reserves the right to communicate with vendors in cases where information is incomplete or where there are obscurities regarding technical aspects of the offer, to obtain confirmation of prices or preference claims in cases where it is evident that a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the supply/service satisfactorily.
- 1.8. ALL DECISIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OF THIS QUOTATION.
- 1.9. The price quoted must include VAT (if VAT vendor). However, it must be noted that the Department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 1.10. The bidder must ensure the correctness & validity of the quotation:

 - (i) that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
 - (ii) it is the responsibility of the bidder to confirm receipt of their quotation and to keep proof thereof.
- 1.11. The bidder must accept full responsibility for the proper execution & fulfillment of all obligations/conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 1.12. This quotation will be evaluated based on the 80/20 points system, specification, correctness of information and/or functionality criteria. All required documentation must be completed in full and submitted.
- 1.13. Offers must comply strictly with the specification.
- 1.14. Only offers that meet or are greater than the specification will be considered.
- 1.15. Late offers will not be considered.
- 1.16. Expired products will not be accepted. All products supplied must be valid for a minimum period of six months.
- 1.17. Used/ second-hand products will not be accepted.
- 1.18. A bidder not registered on the Central Suppliers Database or whose verification has failed will not be considered.
- 1.19. All delivery costs must be included in the quoted price for delivery at the prescribed destination.

- 1.23. Verification will be conducted to identify if bidders have multiple companies and are cover-quoting for this bid.
- 1.24. In such instances, the Department reserves the right to immediately disqualify such bidders as cover-quoting is an offence that represents both corruption and acquisition fraud.
2. SPECIAL INSTRUCTIONS AND NOTICES TO BIDDERS REGARDING THE COMPLETION OF THIS QUOTATION.
- 2.1. Under no circumstances whatsoever may the quotation/ bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
- 2.2. The bidder is advised to check the number of pages and to satisfy himself that none are missing or duplicated.
- 2.3. Quotations submitted must be complete in all respects; however, where it is identified that information in a bidder's response is incomplete in any respect, the said supplier meets all specification requirements and is lowest to quote, the Department reserves the right to request the bidder to complete/submit such information.
- 2.4. Any alteration made by the bidder must be initialed. Failure to do so may render the response invalid.
- 2.5. Use of correction fluid is prohibited and may render the response invalid.
- 2.6. Quotations will be opened in public as soon as practicable after the closing time of quotation.
- 2.7. Where practical, prices are made public at the time of opening quotations.
- 2.8. If it is desired to make more than one offer against any individual item, such offers should be given on a photocopy of the page in question. Clear indication thereof must be stated on the schedules attached.
- 2.9. The Department is under no obligation to pay suppliers in part for work done if the supplier can no longer fulfill their obligation

- 3.1. Quotations shall be lodged at the address indicated no later than the closing time specified for their receipt and in accordance with the directives in the quotation documents.
- 3.2. Each quotation shall be addressed in accordance with the directives in the quotation documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the quotation number and closing date indicated on the envelope. The envelope shall not contain documents relating to any quotation other than that shown on the envelope. If this provision is not complied with, such quotations/bids may be rejected as being invalid.
- 3.3. All quotations received in sealed envelopes with the relevant quotation numbers on the envelopes are kept unopened in safe custody until the closing time of the quotation/ bids. Where, however, a quotation is received open, it shall be sealed. If it is received without a quotation/ bid number on the envelope, it shall be opened, the quotation number ascertained, the envelope sealed and the quotation number written on the envelope.
