SPECIAL CONTRACT CONDITIONS OF QUOTATIONS

1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The Department is under no obligation to accept the lowest or any quote.
- 3.2. The Department reserves the right to communicate in writing with vendors in cases where information is incomplete or where there are obscurities regarding technical aspects of the offer, to obtain confirmation of prices or preference claims in cases where it is evident that a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the supply/service satisfactorily.
- 3.3. ALL DECISIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OF THIS QUOTATION.
- 3.4. The price quoted must include VAT (if VAT vendor). However, it must be noted that the Department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.5. The bidder must ensure the correctness & validity of the quotation:
 - (i) that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
 - (ii) it is the responsibility of the bidder to confirm receipt of their quotation and to keep proof thereof.
- 3.6. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.
- 3.7. This quotation will be evaluated based on the 80/20 points system, specification, correctness of information and/or functionality criteria.
 All required documentation must be completed in full and submitted.
- 3.8. Offers must comply strictly with the specification.

- 4.2. Under no circumstances whatsoever may the quotation/bid forms be retyped or redrafted. Photocopies of the original bid documentation may be used, but an original signature must appear on such photocopies.
- 4.3. The bidder is advised to check the number of pages and to satisfy himself that none are missing or duplicated.
- 4.4. Quotations submitted must be complete in all respects. However, where it is identified that information in a bidder's response is incomplete in any respect, the said supplier meets all specification requirements and is lowest to quote, the Department reserves the right to request the bidder to complete/submit such information.

MAJOR SERVICE TO BOILER A AND B

AT R.K. KHAN HOSPITAL

1. SCOPE OF CONTRACT

This specification calls for the major service to Boiler A and Boiler B, situated at the Boiler House at R.K. Khan Hospital.

2. DETAILED SPECIFICATION

- 2.1. The boilers to be serviced are a horizontal reverse fired unit manufactured by John Thompson Africa model TC280 serial no. 73507 AND serial no.73369.
- **2.2.** The burner units are manufactured by Weishaupt and are paraffin fueled.

3. SERVICE PROCEDURE

All preparatory work is to be undertaken before internal and external inspections.

- 3.1. The boiler is to be isolated from all electrical, water and steam supplies.(in correspondence with the maintenance department)
- 3.2. A visual inspection is to be carried out by certified boiler personal on all tubes prior to cleaning.
- 3.3. All manhole and mud-hole covers are to be removed before the cleaning operation.
- 3.4. Remove all damaged refractories that need to be renewed.
- 3.5. All seams and welds are to be exposed for inspection with the use of a wire brush.
- 3.6. All soot and combustion deposits are to be removed from the fire side.
- 3.7. The boiler tubes and fire side deposits are to be cleaned with the use of a high pressure cleaner.
- 3.8. The post-cleaning internal and external inspection is to be carried out by a certified boiler engineer.
- 3.9. All soot and excess deposits are to be cleaned from the chimney stacks.
- 3.10. The pressure in the boiler is to be raised to the maximum working pressure to ascertain any leaks.
- 3.11. On the successful completion, a calibration certificate must be provided for gauges and safety valves.
- 3.12. The insulation and the glass fibre rope seal on the front door is to be replaced, the door is to be adjusted to ensure there are no leaks.
- 3.13. All valves, including crown valves, isolating valves, safety and blow-down valves are to be inspected and tested.
- 3.14. The non-return and solenoid valves on the feed water line are to be inspected and cleaned.

- 3.15. The feed water pump is to be tested and serviced accordingly.
- 3.16. All water alarms are to be tested.

11. TAX INVOICE

- 11.1. A tax invoice shall be in the currency of the Republic of South Africa and shall contain the following particulars:
- (i) the name, address and registration number of the supplier;
- (ii) the name and address of the recipient;
- (iii) an individual serialized number and the date upon which the tax invoice is issued;
- (iv) a description and quantity or volume of the goods or services supplied;
- (v) the official department order number issued to the supplier;

12. PATENT RIGHTS

The supplier shall indemnify the KZN Department of Health (hear after known as the purchaser) against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
