2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract,

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The Department is under no obligation to accept the lowest or any quote.
- 3.2. The Department reserves the right to communicate in writing with vendors in cases where information is incomplete or where there are obscurittes regarding technical aspects of the offer, to obtain confirmation of prices or preference claims in cases where it is evident that a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the supply/service satisfactority.
- 3.3. ALL DECÍSIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OR CANCELLATION OF THIS QUOTATION.
- 3.4. The price quoted must include VAT (if VAT vendor).
- 3.5. Should a bidder become a VAT vendor after award or during the implementation of a contract, they may not request the VAT percentage from the Department as the service provider made an offer during the period they were not registered as a VAT vendor. The Department is only liable for any VAT from registered VAT vendors as originally stated on the quotation document.
- 3.6 The bidder must ensure the correctness & validity of the quotation:
 - (i) that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
 - (ii) It is the responsibility of the bidder to confirm receipt of their quotation and to keep proof thereof.

8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

9. SUBMISSION AND COMPLETION OF SBD 6,1

9.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference points allocation. The preferences applicable on the closing date will be utilized. Any changes after the closing date will not be considered for that particular quote.

10. TAX COMPLIANCE REQUIREMENTS

- 10.1. In the event that the tax compliance status has failed on CSD, it is the suppliers' responsibility to provide a SARS pin in order for the institution to validate the tax compliance status of the supplier.
- 10.2. In the event that the institution cannot validate the suppliers tax clearance on SARS as well as the Central Suppliers Database, the quote will not be considered and passed over as non-compliant according to National Treasury Instruction Note 4 (a) 2016/17.

11. PATENT RIGHTS

The supplier shall indemnify the KZN Department of Health (hereafter known as the purchaser) against all third-party claims of infringement of patent, trademark or industrial design rights arising from use of the goods or any partitiere of by the purchaser.

12. PENALTIES

- 12.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and if deemed necessary, the institution may extend the service provider's time for performance.
- 12.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the service provider's expense.
- 12.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.
- 12.4. 1. PROJECT SPECIFICATIONS

1.1 SCOPE OF CONTRACT

This Contract is for the execution of the project indicated above.

1.2 CONTRACT DRAWINGS

This tender document is to be read in conjunction with the drawings listed below which is issued together with this document.

Drawings: No drawings provided.

These drawings may be updated from time to time during the course of the Contract, and the Contractor must ensure at the time of the installation that he has the latest copy of all drawings. No claim will be considered for work, which requires to be changed due to the use of outdated drawings.

1.3 CONDITIONS OF CONTRACT AND PRELIMINARIES

1.3.2.1 PENALTIES FOR NON COMPLECTION DEFAULT FOR NON COMPLETION.

Penalties at rate of 7% of the contract value per day shall apply.

1.3.1 PERIOD OF CONTRACT

Four (4) Weeks as the Contract Period for the completion of the Work from date of Site handover.

1.3.2 CONTRACT GUARANTEE:

The Successful Bidder will be required to submit a contract guarantee.

1.3.3 GUARANTEE PERIOD

The guarantee period for the completion of the Roof replacement, Painting all structural - work and all materials must be a minimum of <u>Twelve (12) Calendar Months</u> from the date of first delivery.

1.3.4 SITE AND MODE OF PROCEDURE

The work contained in this contract will be carried out on the site of the existing Grange Clinic.

The Bidder is advised that the existing premises will be occupied throughout the period of the contract, and that the minimum amount of disruption to services is of the utmost importance.

Damage to the existing buildings - Bidders to note that any damages done or occurring to any of the buildings will be repaired at the expense of the contractor/Bidder.

The repairs or installation must be to the satisfaction of the Kwazulu-Natal Department of Health. Bidders are advised to visit the site prior to tendering and to acquaint themselves with the nature of the work to be done and access to the siting of the existing buildings etc., as no claim whatsoever will be allowed on the grounds of ignorance of the conditions under which the work will be executed.

1.3.5 SATISFACTORY INSTALLATION

1.3.6 GENERAL

The Bidder's / Contractors will be responsible for all masonry work associated with the roof replacement and making good of all work related. The patching and painting must be to the satisfaction of the KwaZulu-Natal Department of Health.

2.1 GENERAL

This TECHNICAL SPECIFICATION shall be read in conjunction with all other sections of the SPECIFICATION and cognisance shall be taken of the clauses relevant to this particular installation, whether any specific clauses are referred to or not.

3. SCOPE OF WORK

The work to be carried out under this contract includes the supply of all materials, painting, tiling, and marine ply wood and including all labour to paint and leaving in service condition to the satisfaction of the Project leader for Health: KwaZulu-Natal.

3.1. The work comprises of:-

- 1) Allow to remove existing corrugated iron roof
- 2) Allow to remove fascia/barge board
- 3) Allow to remove existing gutters and down pipes and to re-install.
- 4) Allow to beam fill under roof sheeting

- b) New Chromadek ridging
- c) New Sisalation RSA 420

- h) New purlins (treated
- i) To paint expose roof timber
- j) New Sondor Polyclosure and lapseal
- k) New H-profile fascia joiners including screws
- l) OHS Act Plan.

3.3 STANDARD PREAMBLES TO ALL TRADES

The Bidder shall carry out all work according to the Standard Preambles to all Trades. The standard preambles can be obtained from Department of Health Facilities Management.

3.4 REMOVAL OF ROOF SHEETING

All the existing roof sheeting including Sisalation, fascia/barge boards, valley lings, ridging, gutters, Whirly Birds, down pipes and purlins must be removed without any damages to roof trusses.

3.5 PAINTING TO ROOF TIMBER

The exposed roof timber must be painted before installation of roof sheeting with coats of ABE Provinite

3.6 ROOF COVERING

The preferred roofing material is Galvanised sheeting with a "Chromadek" finish of specified colour 0.08mm thick roof sheeting fixed on 50 x 75mm purlins at 1m c/c maximum spacing with Tek screw and bonded washers. Hurricanes clips left and right Hand to be fixed on roof trusses and purlins at 7per sq/m. Sisalation RSA 420 must be installed under roof sheeting and "Sondor Polyclosure" and lapseal under 0.08mm Galvanised ridging Chromadek.

3.7 BEAM FILLING

Beam filling must be bricks and motor infill to underside of roof sheeting to match the existing wall and it must be plastered if necessary and painted to match existing colour.

3.8 FASCIA AND BARGE BOARDS

The preferred is 300mm Nutec Fibre Cement fascia or uPVC 300mm fascia board fixed to roof trusses and purlins with Galyanised flat washers and screws including plastic H-profile fascia and barge board joiners.

3.9 GUTTERS

The preferred gutters material is Aluminium "Superspan Type Ogee pattern to be fixed on falls to fibre cement fascia including gutter bracket in suitable spacing. Rain water pipes must be complete Aluminium including extra over for bend and extra over for shoe fixed to wall. Down pies must discharge over sump connected to storm water system.
