1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

### 3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The Department is under no obligation to accept the lowest or any quote.
- 3.2. The Department reserves the right to communicate in writing with vendors in cases where information is incomplete or where there are obscurities regarding technical aspects of the offer, to obtain confirmation of prices or preference claims in cases where it is evident that a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the supply/service satisfactorily.
- 3.3. ALL DECÍSIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OR CANCELLATION OF THIS QUOTATION.
- 3.4. The price quoted must include VAT (if VAT vendor).

## 8. STATEMENT OF SUPPLIES AND SERVICES

- Should a contractor indicate a special discount on his/her account provided payment is 16.2 made within a certain time, every effort shall be made to take advantage of such discount.
- Any query concerning the non-payment of accounts must be directed to the Finance. The 16.3 following protocol will apply if accounts are queried:
  - Contact must be made with the officer-in-charge of the Facility; (i)

#### PENALTY CLAUSE 17.

In the event that the contract is not completed on scheduled completion date, penalty amount of 0.04% of contract sum will be charged per day for extra days taken after scheduled completion date. The amount shall be deducted from outstanding payments.

### PROVINCIAL SUPPLIERS DATABASE AND CIDB 18.

A Constructor submitting quote must be registered on the Provincial Suppliers Database and CIDB. A Contractor not registered on the Provincial Suppliers Database and CIDB, quote will not be considered.

### SPECIAL CONDITIONS OF CONTRACT 19.

The tender is issued in accordance with the provisions of the Public Financial Management Act (PFMA), Chapter 16 A of the Treasury Regulations and shall be subject to the provisions of the General Conditions of Contract. The Special Conditions of Contract are supplementary to that of the General Conditions of Contract. Where, however, the Special Conditions of Contract are in conflict with the General Conditions of Contract, the Special Conditions of Contract prevail.

#### **TAX AND DUTIES** 20.

#### **UNSATISFACTORY PERFORMANCE** 21.

days minimum). If the contractor does not perform satisfactorily despite the warning the Facility will:

- take action in terms of its delegated powers (i)
- make a recommendation to its Head Office for cancellation of the (ii) contract concerned.
- When correspondence is addressed to the contractor, reference will be made to the contract (b) number/item number/s and an explanation of the complaint.

# VALIDITY PERIOD OF BID AND EXTENSION THEREOF

The validity (tendering) period for the bid must be 90 days from close of quote. However, circumstances may arise whereby the Facility may request the bidders to extend the validity (tendering) period. Should this occur, the Facility will request bidders to extend the validity (binding) period under the same terms and conditions as originally tendered for by bidders. ### PART 1

## 1. GENERAL

## 1.1 SCOPE OF WORK

The current scope of work below entails BOQ

- a) The preferred bidder will be required to provide only competent personnel to perform all duties as per BOQ.
- b) Fabricate stainless steel shelving with 304 square tubing ensure that all ends are closed / covered:





Figure 1: Top View

- i) Use 25mm 304 stainless steel tubing to fabricate frame supported at 1500mm
- ii) Frame must be 3000mm x 7\00mm (width x depth), see figure 1 above.
- iii) Use 20mm 304 stainless steel tubing across the frame with 50mm apart, all corners must 90°
- iv) Shelving must be well clean and smooth without holes.
- v) Frame height must be 1900mm and squire tubes across the frame to make 3-tier shelving 600mm apart starting from 100mm from the ground, see figure 2 below.
- c) Clean the area.

- d). Fabrication must not be done within or around the facility premises, only final joints can be performed on site during installation.
- e) The contractor should consider the BOQ below and confirm measurements.
