## 1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be sig parties.

### 2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domiciliu executandi) details change from the time of bidding to the expiry of the contract.

# 3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The Department is under no obligation to accept the lowest or any quote.
- 3.2. The Department reserves the right to communicate in writing with vendors in cases where information is incomplete or whe obscurities regarding technical aspects of the offer, to obtain confirmation of prices or preference claims in cases where it is a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the su satisfactorily.
- 3.3. ALL DECISIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OR CANCELLATIO: QUOTATION.
- 3.4. The price quoted must include VAT (if VAT vendor).
- 3.5. Should a bidder become a VAT vendor after award or during the implementation of a contract, they may not request the VAT from the Department as the service provider made an offer during the period they were not registered as a VAT vendor. - 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider mi institution in writing/email of the cause of and the duration of the delay. - 13.4. ## 14. TERMINATION FOR DEFAULT
