

  - The Department reserves the right to communicate in writing with vendors in cases where information is incomplete or where there are obscurities regarding technical aspects of the offer, to obtain confirmation of prices or preference claims in cases where it is evident that a typing, written, transfer or unit error has been made, to investigate the vendor's standing and ability to complete the supply/service satisfactorily.
  - ALL DECISIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OR CANCELLATION OF THIS QUOTATION.**
  - The price quoted must include VAT (if VAT vendor).
  - Should a bidder become a VAT vendor after award or during the implementation of a contract they may not request the VAT percentage from the Department as the service provider made an offer during the period they were not registered as a VAT vendor. The Department is only able for any VAT from registered VAT vendors as originally stated on the quotation document.
  - The bidder must ensure the completeness & validity of the quotation.
    - that the prices, rates & preference quoted cover all for the work/er (s) & accept that any mistakes regarding the price (s) & calculations will be of the bidder's risk
    - it is the responsibility of the bidder to confirm receipt of their quotation and to keep proof thereof.
