

The Department reserves the right to cancel any bid in writing and consider it invalid if there are anomalies regarding technical aspects of the offer, to obtain confirmation of prices or preference points in cases where it is evident that a typewriter, keyboard or other error has been made to investigate the vendor's standing and ability to complete the supply/procure satisfactorily.
 3. **ALL DECISIONS TAKEN BY THE DEPARTMENT ARE FINAL, INCLUDING THE AWARD OR CANCELLATION OF THIS QUOTATION.**
 4. The price quoted must include VAT (if VAT applies).
 5. Should a bidder become a VAT vendor after award or during the implementation of a contract, they may not request the VAT percentage from the Department as the service provider made an offer during the period they were not registered as a VAT vendor.
