#### 8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

#### 9. SUBMISSION AND COMPLETION OF SBD 6.1

## Specification for pest control service, supply and installation of rodent bait station

## 1. Ward/department/areas ( as per list attached )

This pest control service contract is for the eradication and control of all pest and vermin (rats, mice, cockroaches, bird lise all types of ants, moth larvae, fish moths etc....) at Richmond Specialised TB Hospital under KwaZulu-Natal Department of health.

This service Contract does not cover the <u>eradication of Termites (White ants, bees or mosquitoes.</u> Should an exceptional situation arise where the institution requires the eradication or treat, ant of termites ,bees and Mosquitoes, a separate quotation based on the travelling and hourly rates as indicated in the price schedule will be called for.

#### 2. RE-INFESTATION

If in between each four weekly service, re-infestation of any type of pest becomes apparent, the contractor will be required to provide an immediate re-service in the specified infested area at no cost, and to complete satisfaction of the administration

#### 3. Service procedure

- No service is to be carried out before the contractor has made prior arrangement for service date with the officer in charge systems manager or IPC manager.
- A schedule of service date must be drawn by the service provider and communicated to hospital, preferable 3 months . this will ensure the service provider is given access to services areas on the day of service.
- A detailed worksheet must be drawn up and completed by the pest control offer carrying out the fumigation. The worksheet would indicate all the different areas fumigated by which ever means relevant to the area keeping safe being hazardous to food patients and staff members
- Such service date arrangement shall be made at least seven days prior to the actual proposed service date
- On arrival at the institution on the date of service, contractor will be required to report to the office of the Infection Prevention and Control Manager (IPC) to sign into the contract register before any service takes place.
- On completion of the service the contractor will once again be required to report to IPC manager office to sign out of the contractor register

#### 4. SCOPE OF SERVICE

- Only competent and trained persons are to handle insecticides/Pesticides.
- The contractor should be a member of the South African Pest Control Association
- Every room or enclosure in the wards or department is to treated with baits, insecticides and pesticides per SABS codes of practice
- All equipment's used should abide by the Occupational Health and safety act 85 of 1993
- Provision must also be made for the application of chemical gel in strategic areas of each ward or department after chemical spray
- · All built in cupboards shall be internally sprayed and treated
- All storage rooms such as kit rooms , surgical storage rooms etc are to be treated with spray and gel
- All plant rooms and basement areas are to be spray treated and rodent bait treated
- All sewerage and storm water manholes are to be opened and sprayed treated at each service
- All down pipes areas, water pipe, ducting pipes
- Refrigerator moto, vending machine and skirting boards
- Fire hose reels
- Patients lockers and staff lockers

# The contractor is to be in possession of his own tools and equipment to open sewerage and storm water manholes

The surroundings of every open type water gulley shall be spray treated at each service. The edges of all concrete walkways within enclosed passages shall be sprayed and treated at each service

#### 5. <u>Insert control</u>

Insert control should be done using spraying and powder wherever necessary

#### 6. Rodent control

Indoor trapping: Rodent control inside occupied building shall be accomplish with trapping devises only: all such devices shall be concealed and in protected areas so as not to be disturbed by hospital operations contractor or designated hospital representative will be responsible for disposing of all trapped rodents or rodents carcasses in appropriate manner

#### Outdoor use of bait boxes:

All bait boxes shall be placed out of general view where they will not be disturbed by Hospital operations. The lid of the boxes shall be securely locked all bait boxes shall be attached to the floors, walls or other immovable surface so that the box cannot be picked or moved.

#### 7. Pest control plan of work

The pest control plan of work will contain two service plans, initial plan and monthly plan

Initial inspection: The contractor will inspect the entire institutions so to identify areas where they will install bait boxes

List of proposed materials and equipment: the contractor shall provide current labels and material safety data sheet for all pesticides product to be used in addition the brand name shall be provided for all applications equipment, rodent bait boxes, monitoring trapping devices and other equipment's that may be used to render the service.
