8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of auspiles delivered or services executed. If he/she falls to do so, the Department may, without prejudice to any other rights which it may baye, institute inquiries at the expense of the contractor to skip the required particulars.

9. SUBMISSION AND COMPLETION OF SED 6.1
