The purpose of this document is to:

- Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government. (ii)

- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, 22.1. the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

### Termination for default

- 23 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract 23.1.

#### 8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. 

Project Description:

Imbalenhle CHC- Construction of new retaining wall, fencing, guardhouse, additional parking and storm water management

## 1. Project Background and Specification

Imbalenhle Community Health Centre is situated in the township of Imbali Unit 3 (Ward 22) of Pietermaritzburg under the District of uMgungundlovu in Kwazulu Natal which serves an estimated population of 1, 066 148 from 11 municipal wards.

A site visit was conducted at Imbalenhle CHC, after the CEO notified the Engineering and Technical Services Directorate about her fears of the steep sloped bank that is not retained which is approaching the concrete fence on the top of the bank.

The following concerns for both institutions:

- Chunks of rocks fall from the bank.
- The concrete fence is in bad state and the bank is now approaching the base of the fence.
- Health and Safety issues resulting from the risk of collapse.
- Health and Safety issues that may arise out of traffic accident with the risk of car hitting the fence and falling onto the clinic.

The clinic is built on a very deep cut to fill site with the deep cut as high as 12m and tampering in triangular shape down to origin natural ground and to the fill portion and a bank down to natural ground. The fill portion is also high, well grassed, well maintained and stable. The soil structure on the cut is decomposed shale of which the surface shows signs of being brittle.

The slope was observed in dry conditions where no evidence of groundwater was observed. Furthermore on the platform there is no evidence of high water table observed, however caution is recommended to reduce risk.

There is no evidence of foundation failure. However there is no evidence of slope stability failure yet (Shear Failure) under static conditions, yet failure under dynamic conditions (tremor) or heavy pore water pressure cannot be ruled out.

A ring road surrounds the entire complex, which is generally good engineering practice in terms of storm water management and debris control, however some temporary and semi-temporary structures have been built of the slope side of the road and those maybe at risk. Heavy pore water pressure can result from failure of municipal storm water management on the municipal road and heavily built up areas on the upper catchment.

It is good practice to have un-retained banks that are a maximum of 1:3. The banks observed are less and in some instances 1:1 or even less as a result the risk of the cut face exists. The risk on the fill slope is more stable for as long as the site catchment is managed. The risk exists on the high fill slope if there is a municipal storm water failure.

## Mitigation of risk:

**Cut Slope:** The cut slope exceeds the limit of un-retained bank, therefore imperative that a retaining solution needs to be implemented with a fair degree of urgency. The retaining wall needs to be engineered and not just built. The engineering will determine the type and height as they are different types of solutions depending on the engineering risk;

- Gabion retaining wall
- Block retaining wall
- Reinforced concrete wall
- Any of the above with piles driven to counter severe shear failure.

Fill Slope: The risk at the fill face is lower, therefore toe stability is required. There is evidence of some toe stability; however a detailed engineering assessment is required

**Fence:** The fence is a dilapidated concrete panel fence. It is recommended that the fence be replaced with a clear welded mesh fence built on at least 500 mm above ground engineered brick plinth right round with paved slope to the municipal road with kerbs and guard rail on the backside of the kerb to protect fence.

Retaining is a specialist work, so procurement must include services of a specialised retaining experts based on the engineering accepted solution at Concept and Viability. Assessment of 1:50 flood to determine the adequacy of the existing storm water management plan and facilities on site.

Appointed consultants to do a detailed risk assessment to determine the speed of execution and advise if pile foundations are required for the retaining wall.

The engineering concept assessment will therefore advise on the number parking bays in terms of requirements and availability of space



The following is the scope of work:

## Construction of Perimeter Fencing

- Site Clearance and Removal of the existing concrete perimeter fencing
- Erection of new perimeter fence including gates
- The estimated perimeter fence would be 507 metres in length and height of 2,4 metres right round the facility including one vehicle and one pedestrian gates
- The fence must be incapable of being vandalised and must have anti-cut, anti-climb, and anti-burrow provisions.
- The fence must be sturdy and firm structurally.
- The fence must be resistant to weather attacks and climate conditions (e.g. corrosion).
- All the steel materials shall be of good commercial quality.
- All the fixtures and connections must be on the inside of the fence and therefore must not be accessible from the outside.
- All the materials for the fence must be cut to size and prefabricated off site to prohibit any cutting and welding taking place on site.
- All the fence must be specified with a coloured protective coating that is not commonly found in the vicinity of the facility and must not be natural zinc finish because this is a common finish/colour of a fence and therefore makes it easier to steal for re-use or for selling. The chosen colour must blend in with the aesthetics of the facility but must also be capable of being mass produced to reduce production costs. This is to deter the criminals from stealing and re-using the fence panels elsewhere or from selling them for scrap metal.
- All the fencing material shall be supplied and installed by the same supplier but without negating potential sub-contracting arrangements. The main supplier shall remain solely accountable for all the guarantees/warranties for prefabricating, delivering and installing the fence material, therefore no third party arrangements shall be considered in this regard.

- Barbed wire strands and woven diamond-mesh or chain-link mesh shall not to be used.
- Perimeter lighting for the entire facility.
- Provision of Land Surveyor to confirm facility boundary

## Construction of guardhouse

- Construction of Guard house, including toilet and kitchenette counter and all auxiliaries

The Construction Project Manager (NEC3 Project Manager) may also assume the role of Supervisor if suitably qualified and experienced as per the stated requirements.

## 29. Conditions of Appointment

- 29.1. The Entity must have within their employment or display their ability to have access to the professional consultants as listed in paragraph 29.1 above. Construction Project Management Services cannot be outsourced and must be provided in-house by the bidding entity. Bidders are to provide a letter outlining the services to be provided in-house by the bidding entity, as well as letters of agreement securing Professional Services for those professional disciplines to be provided by others. Outsourced services agreement letters are to be signed by the bidder and the Principal of the outsourced firm and be on the bidder's official company letterhead. Furthermore, Form A must be completed confirming the firm and Registered Professional proposed to the project for each service.
- 29.2. The Professional individuals named as part of the project team (as per Form A) must play an active and visible role on the project. The stated Professional individuals must attend a minimum of 70% of all meetings in which they are required. Failure to comply with this condition will constitute a breach of this contract.
- 29.3. Consultants must submit all returnable documents as listed on Appendix B herein. Failure to submit all the requested documents will result in the bid not being considered.

- C2.1 Pricing Instructions
- C2.1.1 Basis of remuneration, method of tendering and estimated fees
- C2.1.1.1 Professional fees for the Multi-Disciplinary Services will be paid on Value basis.

The words "value based" and "percentage based" used in connection with fee types in this document or any documents referred to in this document are interchangeable and are deemed to have the same meaning.

C2.1.1.2 Tenderers are to tender:

A value based fee utilizing the stated estimated project construction value multiplied by a fixed tendered percentage which is then apportioned amongst the multi-disciplinary team.

- C2.1.1.3 The amount tendered herein is for tender purposes only and will be amended according to the application of the actual cost of construction.
- C2.1.1.4 Reimbursable rates for typing, printing and duplicating work shall be in accordance with the conditions laid out under section C2.1.5
- C2.1.1.5 <u>Disbursements in respect of all travelling and related expenses</u> including all travelling costs, time charges and subsistence allowances related thereto <u>will not be paid for separately</u> except for attending off-site meetings at the request of the employer where only travelling costs (mileage only) shall be claimable in accordance with the rules set out in C2.1.6.3

The site must be visited as often as the works require for the execution of all duties on the Project. The Service Provider must be available at 24 hours' notice to visit the site if so required. All costs in this regard will be deemed to be included in the tendered fees as stated in C2.1.1.1

- C2.1.1.6 All fee accounts need to be signed by a principal of the Service Provider and submitted in original format, failing which the accounts will be returned. Copies, facsimiles, electronic and other versions of fee accounts will not be considered for payment.
- C2.1.1.7 For all Services provided on a time basis, time sheets giving full particulars of the work, date of execution and time duration, should be submitted with each fee account.
- C2.1.1.8 Payments to the Service Provider will be made electronically according to the banking details furnished by the Service Provider. Any change in such banking details must be communicated to the departmental project manager timeously. Fee accounts, correct in all respects, will be deemed submitted when received by the Employer and settled when electronically processed by the Employer. The Employer reserves the right to dispute the whole account, any item or part of an item at any time and will deal with such case in terms of clause 14.3 of the General Conditions of Contract.
- C2.1.1.9 Accounts for Services rendered may be submitted on the successful completion of each stage of work. Interim accounts will only be considered during the construction stage of the works and then not more frequently than quarterly except if otherwise agreed between the authorised and designated representative of the Service Provider and the Employer. Payment of accounts rendered will be subject to the checking thereof by the departmental project manager. The Employer reserves the right to amend the amounts claimed in order to conform to the rates stipulated in this Contract and make payment on the basis of the balance of the account in accordance with clause 14.3 of the General Conditions of Contract.

## C2.1.2 Value based fees

C2.1.2.1 Fees for work done under a value based fee shall be calculated according to the tendered percentage for fees for the team and apportioned to construction stages (for each professional discipline) according to the applicable stated tariff of fee guide according to the latest Government Gazettes.

## C2.1.2.2 Interim payments to the Service Provider

For the purposes of ascertaining the interim payments due, the cost of the works, which shall exclude any provisional allowances made to cover contingencies and escalation, shall be:

- · the applicable portion of the net amount of the accepted tender
- C2.1.2.3 Fees for documentation for work covered by a provisional sum

  Where a provisional sum is included in the bills of quantities for work to be documented at a later stage, the documentation fee in respect of such work shall be remunerated at the time when the documentation has been completed.
- C2.1.2.4 Time charges for work done under a value based fee (upon approval by Head of Health)

No separate payment shall be made. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

C2.1.3.3 Quality Assurance System

No separate payment shall be made for the implementation of a quality management system. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

C2.1.3.4 Lead Consulting Engineer

No separate payment shall be made for assuming the leadership of an Employer specified joint venture, consortium or team of consulting engineers. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

C2.1.3.5 Principal Agent of the Client

No separate payment shall be made for assuming the role of principle agent. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

## C2.1.3.6 Environmental Impact Assessment

No separate payment shall be made for the service. The cost of providing this service shall be deemed to be included in the value based fee tendered for normal services.

## C2.1.4.1 Reimbursable rates

## C2.1.4.2 Typing and duplicating

If the Service Provider cannot undertake the work himself, he may have it done by another service provider which specializes in this type of work and he shall be paid the actual costs incurred upon submission of statements and receipts which have been endorsed by him confirming that the tariff is the most economical for the locality concerned subject to the maximum tariffs per A4 sheet as set out in Table 1 in the "Rates for Reimbursable Expenses".

If the Service Provider undertakes the work himself, he shall be paid in respect of actual expenses incurred subject to the maximum tariffs per A4 sheet as set out in Table 1 in the "Rates for Reimbursable Expenses".

Typing and duplicating expenses shall only be refunded in respect of the final copies of the following documents namely formal reports, formal soil investigation reports, specifications, feasibility reports, bills of quantities, material lists, minutes of site meetings and final accounts. The cost of printed hard covers shall only be paid in respect of documents which will be made available to the public such as bills of quantities and specifications or where provision of hard covers is specifically approved.

The typing of correspondence, appendices and covering letters are deemed to be included in the value based fees and time based fees paid.

## C2.1.5 Travelling and subsistence arrangements and tariffs of charges

Notwithstanding the ruling in C2.1.1.5 above (regarding disbursements and travelling expenses which will not be paid separately), when the Service Provider is requested in writing by or obtained prior approval in writing from the Employer to attend specific meetings at any of the Employer's offices or any extraordinary meetings on site or elsewhere, he will be remunerated according to the provisions under C2.1.6.1 to C2.1.6.3 herein.

### C2.1.5.1 General

The most economical mode of transport is to be used taking into account the cost of transport, subsistence and time. Accounts not rendered in accordance herewith may be reduced to an amount determined by the Employer.

As the tariffs referred to hereunder are adjusted from time to time, accounts must be calculated at the tariff applicable at the time of the expenditure.

Where journeys and resultant costs are in the Employer's opinion related to a Service Provider's mal- performance or failure, in terms of this Contract, to properly document or coordinate the work or to manage the Contract, no claims for such costs will be considered.

C2.1.5.2 Travelling time

No travelling time shall be paid on this project.

C2.1.5.3 Travelling costs

Fees for travelling costs are as set out in Table 3 in the "Rates for Reimbursable Expenses".

Travelling costs will be refunded for the full distance covered per return trip measured from the office of the Service Provider appointed provided that the destination is greater than 50km away (one way) from the Service Provider's stated office address at the time of tender. Travelling costs related to trips to the site shall not be claimable and will be deemed to be included in your tendered professional fee, Travel costs will only be considered where the Service Provider has been requested to attend an off-site meeting with the destination being further than 50km (one way) from the Service Provider's office.
