SPECIFICATION - CLEANING OF GARDENS AND GROUNDS

PERIOD OF CONTRACT - (06) SIX MONTHS

SPECIFICATION APPLICABLE TO THE CONTRACTOR FOR THE STANDARD CLEANING AND DAY TO DAY MAINTENANCE OF GARDENS AND GROUNDS FOR THE PERIOD OF (06) SIX MONTHS.

1. SCOPE OF WORK

Areas of responsibility are as follows

- 1.1 Garden maintenance of all garden areas within defined property area.
- 1.2 Mowing of all grass areas including nature strips at the property
- 1.3 Rubbish and debris to be removed from all areas within property
- 1.4 Sweeping /blowing of all pathways, ground gutters & driveways of all refuse following completion cutting areas within the property
- 1.5 Trimming and pruning of trees including trees /shrubs within the branch and those overhanging any pedestrian path or walkway according to Council regulations
- 1.6 Removal and replacement of fallen /dead trees /shrubs / plants within property (as required and quoted)
- 1.7 Weeds are to be removed from all areas within the property and weed control to be maintained
- 1.8 Contractor must submit Job Safety Analysis sheets and Material Safety Data Sheets for all works
- 1.9 All garden refuse to be removed from site on a weekly basis in line with the accepted waste Management practices

2. SPECIFICATION

Grassed area Maintenance

- 2.1 Prior to mowing all grassed areas are to be cleaned of papers, rubbish, large stones, tree branches and other obstacles
- 2.2 All grassed areas including nature strips adjoining the property are to receive the attention required on each scheduled visit.
- 2.3 Grass and weeds are to cut to a height considered normal for grassed areas or as directed (approximately 50 70 mm) Height of grass and weeds are not to exceed 150mm
- 2.4 Lawn edges to buildings, pathways, fences or other structures and garden beds are to be trimmed and to the level with the adjacent mowed area.
- 2.5 Edges shall be trimmed to reveal the edge of the path, kept and fenced lines
- 2.6 Grass around the trees and shrubs in lawn areas to be trimmed to the butt.

Shrubs

- 2.7 At these locations (approval) spraying of herbicides may be used to control the grass, particular care to be taken not to ring bank and trees or bush.
- 208 Pathways, ground gutters and gutters are to be swept/blown clean after the completion of mowing.
- 209. All grassed areas to be moved in accordance with relevant Job Safety Analysis where required
- 210. Any recommendations for improvements to property lawn/grass areas are to be discussed with relevant site manager.

Garden Bed Maintenance (Gardening and Weeding)

- 211. Garden beds are to be kept in a well presented, neat fashion
- 212. Weeds are to be removed from all garden beds, grounds, car parks and other areas within the property area.
- 213. All shrubs / bushes / plants are to be pruned and shaped where required with relevant Job Safety Analysis
- 214. All rubbish within garden beds is to be removed and taken of site

Tree Work

- 215. Tree branches are to be trimmed to provide a vertical clearance from the drive way and car parking surfaces of 4 meters.
- 216. Trees and shrubs are to be pruned to a height of 4 meters to avoid interference to pedestrians, cars, cyclist and vehicles.
- 217. Corridor clearance at entry/exit to site/ property to be maintained for the safety of pedestrians / vehicle traffic
- 218. Fallen trees, shrubs and dead foliage are to be cut out and removed as required by the institution. Upon removal of shrubs, replacements of work are to be put in place with the agreement of institution.
- 219. All mature and juvenile trees are to be pruned in accordance with relevant Job Safety Analysis.
- 220. Trained personnel to carry out advanced tree work at the request of institution

Car park / Pathways Maintenance

- 221. All rubbish is to be removed and taken off site
- 222. Leaves and rubbish that have accumulated against buildings, walls, pathways, and drains shall be picked up and removed.
- 223. Weed control is to be established through the use of herbicides in all car park /

pathways areas

- 224. Poison application will adhere to all departments of primary industry standards.
- 225 At completion of works, all areas are to be cleaned of garden refuse to ensure areas are free of leaf, litter, dirt, etc.
- 226. Monthly inspections of drains / pits /gutters, etc. are to be performed with each maintenance visit and report on when work is required, as excess buildup of leaves and twigs can impede water flow.
- 227. When necessary, areas are to be serviced and cleaned as agreed upon by institution.

Mulching

- 228. The contractor is to maintain areas within the property, musing general brush mulch.
- 229. Mulch is to be kept to a level of 50 75 mm with regular trimming to keep mulch aerated (every 2^{nd} visit)
- 230. Mulch top-ups to be applied every 6 months to establish appropriate level.

Site Clean -up

- 231. During the course of the work the Contractor shall keep the site in a clean and safe Condition.
- 232. The Contractor is directly responsible to ensure the work site / area is kept neat at all times and must be totally cleaned up on completion of the works by the contractor.
- 233. The contractor will be recalled to carry out a clean-up at the contractor's cost and time if found otherwise.

Perimeter fence

234. The interior area around perimeter must be cleaned of alien vegetation, weeds,

vines growing mesh fencing must be poisoned and removed.

235. One (1) meter inside and outside area around perimeter fence must be kept clear as stipulated by the institution

Site improvements and Periodical Replanting Works

The Contractor will provide from time to time recommendations on improving the site's garden beds, lawn/grass areas and what else will improve the property appearance.

Collection of garden refuse

The Contractor must provide black refuse bags on site for collection of garden refuse.

The garden refuse MUST be collected and removed from site weekely.

GCC

NOTES

The purpose of this document is to:

- Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government. (ii)

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid/quotation documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

1 Definitions

The following terms shall be interpreted as indicated:

- "Closing time" means the date and hour specified in the bidding documents for the receipt of bids. 1.1.
- "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, 1.2. including all attachments and appendices thereto and all documents incorporated by reference therein.
- "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations. 1.3.
- "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement 1.4. process or in contract execution.

Standards

The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

Use of contract documents and information; inspection.

- The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, 5.1. pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance,
- The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for 5.2. purposes of performing the contract.
- Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to 5.3. the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.

- The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall 7,3. be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or a cashier's or certified cheque
- The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion 7.4. of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

Inspections, tests and analyses

Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

Packing

According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

Anti-dumping and countervailing duties and rights

Termination for insolvency 26

The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department 8 1 may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

SUBMISSION AND COMPLETION OF SBD 6.1 g.

Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information 9,1. required, will result in such a bidder not being considered for preference point's allocation.
