

B. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

SUBMISSION AND COMPLETION OF SBD 6.1

9.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. 10 TAX COMPLIANCE REQUIREMENTS

12 PATENT RIGHTS

12.1. The supplier shall indemnify the KZN Department of Health (hereafter known as the purchaser) against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

13. PENALTIES

- 13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.
- 13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities delivered at a later stage at the
- 13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may delin damages from the service provider in the form of a penalty. The service provider's performance should be captured on the service provider database in order to determine whether or not the service provider should be awarded any contracts in the future.
- 13.4. 



The work to be carried out in terms of this section of the project comprises the supply and installation of all the materials necessary, as per the Schedule of Rates.

PART 1

1. SCOPE OF WORK

Partitioning 1

1.1. Supply and install drywall partitioning, all aluminium framework, standard door with Union door lock and window

Dimensions: H-2550mm W-2300mm L-3300mm.

- 1.2. Partitioning to be painted with one coat of primer and two coats Plascon Tawny Mink (VEL 2 code)
 Interior Velvet Sheen.
- 1.3. Create aluminium sliding window 600x600mm.
- 1.4. Supply and install new 1.2m double fluorescent light fitting onto the partitioned area.

Partitioning 2

1.1. Supply and install drywall partitioning, all aluminium framework, standard door with Union door lock.

Dimensions: H-2600mm L-3300mm

- 1.2. Partitioning to be painted with one coat of primer and two coats Plascon Tawny Mink (VEL 2 code).
- 1.3. Supply and connect light switch into the existing light fitting.
