

This specification establishes the requirements, supply, delivery, end user training, demonstration, commission and installation of an intra-operative nerve monitor that monitors nerve integrity of the facial nerve or recurrent laryngeal nerve during ENT surgery. The system offered must compromise of the latest technology. In addition, it should be robust, of proven reliability and user friendly.

NB: The successful bidder will be responsible for the Supply, Delivery and Installation / commissioning of the system at no extra cost to the final bid price. The system must be supplied complete and ready for immediate use.

The system offered must be supplied with the following items and must include the under mentioned listed components in the final total bid price:

GCC

NOTES

The purpose of this document is to:

- Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government. (ii)

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid/quotation documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

1 Definitions

The following terms shall be interpreted as indicated:

- "Closing time" means the date and hour specified in the bidding documents for the receipt of bids. 1.1.

- Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not 23.4. more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed.  - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.

When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24 Anti-dumping and countervailing duties and rights
