- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled soperately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

The following terms shall be interpreted as indicated:
