NOTES

The purpose of this document is to:

- Draw special attention to certain general conditions applicable to government bids, contracts and orders, and
- To ensure that clients be familiar with regard to the rights and obligations of ail parties involved in doing business with government,

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter

- The General Conditions of Contract will form part of all bid/quotation documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

1 Definitions

The following leams shall be interpreted as indicated

- "Closing time" means the date and hour specified in the bidding documents for the receipt of bids
- "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties. 1.2. including all attachments and appendices thereto and all documents incorporated by reference therein.
- "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations 1.3.

- The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for 53
- Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser. 5 4.

6 Patent rights

The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed, If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

9. SUBMISSION AND COMPLETION OF SED 6.1

9.1 Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document.
