



The purpose of this document is to:

- The General Conditions of Contract will form part of all bid/quotation documents and may not be amended
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is, a conflict, the provisions in the SCC shall prevail.

The following terms shall be interpreted as indicated

- 'Closing time" means the date and hour specifiec in the bidding documents for the receipt of bids
