

SCOPE OF WORK FOR ELECTRICAL REPAIR AT PSYCHIATRIC WARD AND PEADS WARD

Requirements:

- 1. Companies must Comply with CSD
- 2. Companies must have Valid CIBD 1 EP/EB
- 3. Companies must have valid letter of good standing from Department of Labor
- 4. Companies must have valid Public Liability insurance with minimum of R 3 000 000
- 5. Companies must have an agreement with Electrical registered companies (Copy for all the document for the company you have agreement with, CK, Registration with Electrical board, CIDB NUMBER, the electrical company)
- 6. All electrical work must be done by Qualified Electrician
- 7. Companies must attach the proof of agreement with fire company to do fire alarm, security system, special doors
- 8. Electrical companies to attach proof of plumbing trade test to do plumbing work
- 9. Electrical Companies to attach proof of Carpenter trade test to do that small ceiling 10.

1. GENERAL

1.1 SCOPE OF WORK

THE CURRENT SCOPE OF WORK BELOW ENTAILS BOQ

- The preferred bidder will be required to provide only competent personnel to perform all duties as per BOQ.
- Supply and deliver all required material and tools for this particular repairs.
- This repairs must be completed within three weeks after order number has been issued, <u>failure to</u> meet the timeframe the facility reserve a right to cancel the order. Handing over Psychiatric Ward to the contractor will be done once the material is delivered on site.
- After handing over the Ward to the contractor, the risk of any loss or damage or theft shall be the responsibility of the contractor. Contractor shall take necessary precations against loss or damage or theft.
- The contractor should consider the BOQ below and confirm measurements prior submitting quotation.
- The contractor shall allow for appointing relevant professionals, all independent statutory obligations for inspections and certificates.
- Contractor must always comply with safety precautions as Psychiatric Ward is adjacent to fully operational Ward.
- Contractor must report the start date 2 days prior commencing repairs.
- No paint shall be used past its maximum life span.
- For any particular work the priming coat and subsequent coats of paint are to be executed with paints from the same manufacturer and in accordance with that manufacturer's instructions. Paint to be brought to the site in unopened containers and no adulteration will be permitted. Painting may be carried out by brush, roller or spray as recommended by the manufacturer and to the approval of the Department. All paints, etc. are to be applied in strict accordance with the manufacturer's instructions.
