**2. Correctness of information and other imperative areas to be considered:**

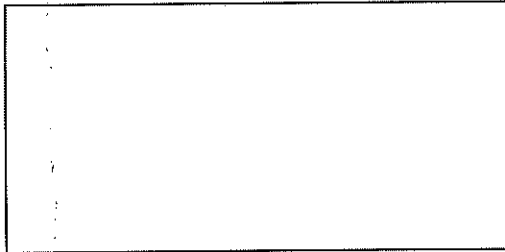
