GCC

NOTES

The purpose of this document is to:

- Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid/quotation documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

1 Definitions

The following terms shall be interpreted as indicated:

- 1.1. "Closing time" means the date and hour specified in the bidding documents for the receipt of bids. 1.2.
- "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties. including all attachments and appendices thereto and all documents incorporated by reference therein. 1.3
- "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations. 1.4.
- "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement 1.5.
- "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6. "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components. 1.7 "Day" means calendar day.
- 1.8. "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9. "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the 1.10. conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained. 1.11.
- "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA 1.12.
- "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions
- "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of 1.13. any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition
- GCC means the General Conditions of Contract.

Standards

The goods supplied shall conform to the standards mentioned in the bidding documents and specifications. 4.1.

Use of contract documents and information; inspection.

- The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, 5.1. pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be 5.2.
- The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract. 5.3.

Performance security



Special Terms and Conditions

1. Introduction

- a) Bidder/s must ensure that they are fully aware of the conditions contained in this bid document, as they shall become the Conditions of Contract once the bid is awarded.
- b) Only bidders that fully meet the specifications shall be accepted.

2. Amendments

a) Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties subject to Bid Adjudication Committee approval.

3. Change of Address

a) Bidders must advise Supply Chain Management should their address details change from the time of bidding to the expiry of the contract.

4. Returnable Documents/ Minimum Requirements

- a) Construction Industry Development Board (CIDB) registration level 1 or above (ME). (attach proof)
- b) Three (3) years proven experience in catering equipment installation or related work. (attach completion certificate)
- c) Proof of available financial credit/bank balance in the approved financial service provider's letter head of not less than R50 000 00, clearly indicating the service provider's account number, name and balance. (attach proof)
- d) Service provider must include the brand name or original equipment manufacturer of the heavy-duty electric range to be supplied, together with its specification. (attach)

NOTE: Failure to submit any of the aforementioned documents shall disqualify the bidder

5. Compliance with Specification, Regulations and Standard Regulations (Including SABS Specifications)

9. Firm Prices

a) This bid requires that all prices offered are firm. If a non-firm price is offered, then the bidder may be disqualified for not complying with the conditions of the bid.

10. General Requirements

Bidders are to make special note of the following:

- a) In-so-far-as the conditions contained herein are at variance with any obtained in the technical specifications, the contract shall be interpreted in terms of the site instructions
- b) Competent workmen skilled in their trade shall carry out all work. Quality shall be of the best standard practice and all workmanship will be subject to the approval by the Department.

11. GUARANTEE

All equipment, material, mechanical work and workmanship provided under the Contract must be guaranteed for a minimum period of twelve (12) months from the date of handing over. The successful bidder must arrange with the Department's engineer and facility manager before for handover and training on the equipment. The bidder to note that the guarantee period must only take effect upon successful handing over and successful test and acceptance by the Department of Health. 14. NOTIFICATION OF AWARD OF BID


