1. AMENDMENT OF CONTRACT

1.1. Any amendment to or renunciation of the provisions of the contract shall at all times be done in writing and shall be signed by both parties.

2. CHANGE OF ADDRESS

2.1. Bidders must advise the Department of Health (institution where the offer was submitted) should their address (domicilium citandi et executandi) details change from the time of bidding to the expiry of the contract.

3. GENERAL CONDITIONS ATTACHED TO THIS QUOTATION

- 3.1. The institution is under no obligation to accept the lowest or any quote.
- 3.2. The price quoted must include VAT (if VAT vendor). However, it must be noted that the department reserves the right to evaluate all quotations excluding VAT as some bidders may not be VAT vendors.
- 3.3. The bidder must ensure the correctness & validity of quote:
 - (i) that the price(s), rate(s) & preference quoted cover all for the work/item (s) & accept that any mistakes regarding the price (s) & calculations will be at the bidder's risk
- 3.4. The bidder must accept full responsibility for the proper execution & fulfilment of all obligations conditions devolving on under this agreement, as the Principal (s) liable for the due fulfilment of this contract.

5. SPECIAL INSTRUCTIONS REGARDING HAND DELIVERED QUOTATIONS

- 5.1. Quotation shall be lodged at the address indicated not later than the closing time specified for their receipt, and in accordance with the directives in the guotation documents.
- 5.2. Each quotation shall be addressed in accordance with the directives in the quotation documents and shall be lodged in a separate sealed envelope, with the name and address of the bidder, the quotation number and closing date indicated on the envelope. The envelope shall not contain documents relating to any quotation other than that shown on the envelope. If this provision is not complied with, such quotations/bids may be rejected as being invalid.
- 5.3. All quotations received in sealed envelopes with the relevant quotation numbers on the envelopes are kept unopened in safe custody until the closing time of the quotation/bids. 8. STATEMENT OF SUPPLIES AND SERVICES

8.1. The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

9. SUBMISSION AND COMPLETION OF SBD 6.1

9.1. Should a bidder wish to qualify for preference points they must complete a SBD 6.1 document. Failure by a bidder to provide all relevant information required, will result in such a bidder not being considered for preference point's allocation. The preferences applicable on the closing date will be utilized. Any changes after the closing date will not be considered for that particular quote.

10. TAX COMPLIANCE REQUIREMENTS

- 10.1. In the event that the tax compliance status has failed on CSD, it is the suppliers' responsibility to provide a SARS pin in order for the institution to validate the tax compliance status of the supplier.

13. PENALTIES

13.1. If at any time during the contract period, the service provider is unable to perform in a timely manner, the service provider must notify the institution in writing/email of the cause of and the duration of the delay. Upon receipt of the notification, the institution should evaluate the circumstances and, if deemed necessary, the institution may extend the service provider's time for performance.

13.2. In the event of delayed performance that extends beyond the delivery period, the institution is entitled to purchase commodities of a similar quantity and quality as a substitution for the outstanding commodities, without terminating the contract, as well as return commodities

delivered at a later stage at the service provider's expense.

13.3. Alternatively, the institution may elect to terminate the contract and procure the necessary commodities in order to complete the contract. In the event that the contract is terminated the institution may claim damages from the service provider in the form of a penalty. Overview


- The Fridge Tag 2 is used to monitor the temperature of vaccines, predominantly during periods of storage. It indicates not only <u>current</u> temperature but also <u>maximum & minimum temperatures</u> for the past 30 days.
- In addition to this, the Fridge Tag 2 has a built-in USB cable tucked into the top of the device, which allows you to plug the unit into a computer and download the past 60 days of recordings in a PDF format (no software required.)

Operating Life

- The Fridge Tag 2 has a 3-year operating life, after which time, it needs to he replaced.
- A <u>Low battery indicator</u> will appear on the display 1 month before the battery expires. This is shown as LOW BATT.

Alarms and Alarm Limits

- This is a WHO approved product. High and Low alarm limits have been pre-set at the factory as per the WHO requirements. The Upper alarm has been set at above +8°C for 10 hours or more. Lower alarm is set at below -0.5°C for 60 minutes or more. These alarm limits are shown as a reminder, on the left hand side of the display on the yellow sticker.
- Temperatures that exceed +8°C or go below -0.5°C for a time period less than the alarm setting duration will not indicate an alarm condition. For example, if temperature is 9.2°C for 2 hours and 15 minutes or down to -1.0°C for 30 minutes, these are not alarm breaches, because it is still less than 10 hours above 8°C and less than 60 minutes below -0.5°C, however, these temperatures and the time duration will be shown in the Read-out mode.

Activation (Set up)

- There are 2 things you will need to set up when you activate the unit:
 1. Set the DATE (Date format dd/mm/yyyy)
 2. Set the TIME (24 Hour Clock) e.g. 1:47pm will be 13:47
- The Fridge Tag 2 arrives in "sleep" mode: The display is blank, Only start the unit
 once you are ready to monitor the fridge temperatures where vaccines are stored.
 A step by step set-up procedure is shown on the insert inside the plastic sleeve of
 your Fridge Tag 2
- In addition to the set up insert, a Youtube video is also available to assist you. Please see the link at the end of this guide.
- Set-up needs to be done once only, thereafter the device runs continuously for its operating life of 3 years. It cannot be stopped and started again. We suggest that one person in the facility should be assigned to do the set-up of all the devices when ready.



Once the date and time has been successfully set up the word "LOC" will appear on the display.

- The word "LOC" will appear on the display when the following 3 actions take place:
 - I. When **set up** is complete
 - 2. During the Read out Mode, if the READ button is not pressed within 30 seconds while you are reading the temperatures.
 - As soon as you press the READ button the Fridge Tag 2 will stop recording temperatures. This is because the device is outside of the fridge and you do not want to take false readings into account you only want to record the FRIDGE temperatures as this is where the vaccines are stored.
 - 3. When the unit is connected to a computer.
- The word "LOC" will indicate that the Fridge Tag 2 is currently NOT recording temperatures for a period of 10 minutes from the time that this first appears., after which normal recording of temperatures will start.
