#### Scope of Work

This specification establishes the requirements of a **static cycle** for use at the physiotherapy department at the respective Hospital. The system offered is required for exercise therapy and must include monitoring of the patient's heart rate during exercise. The system offered must make use of the latest up to date technology.

#### Clause 1

The unit offered must be robustly constructed for commercial use and incorporate comfortable handle bars, a comfortable seat and foot pedals. It would be preferable if the heart rate monitoring device is situated on the handle bars.

N.B. The bidder must provide details, hereunder, on the placement of the heart rate monitoring device.

#### Clause 2

The unit offered must incorporate a variety of exercise programmes viz. manual, weight loss, cardiac, endurance, etc. It must also include a reliable on-board computer program which includes readings for manual, interval, time, distance, incline, calories, heart rate, fit test, warm up, cool down readouts on a display.

#### Clause 3

The display must be centrally mounted on the handle bar and the display must provide clear viewing under all lighting conditions.

The contractor shall, when requested to do so, furnish particulars of supplies delivered or services executed. If he/she fails to do so, the 8.1. Department may, without prejudice to any other rights which it may have, institute inquiries at the expense of the contractor to obtain the required particulars.

# 9. SUBMISSION AND COMPLETION OF SBD 6.1
