



GCC

#### NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- To ensure that cherits be familiar with regard to the rights and obligations of all parkes involved in doing business with government

In this document words in the singular also mean in the plural and vice versa and words in the masculing also mean in the femining and neutro

- The General Conditions of Contract will form part of all bid/quotation documents and may not be amended
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

#### 1 Definitions

11.

The following terms shall be interpreted as indicated.

- "Closing time" means the date and hour specified in the brooking documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, industing all attachments and appendices thereto and all documents incorporated by reference therein.
- 13 Confract prical means the price payable to the supplier under the contract for the full and proper performance of his confractual obligations.
- 1.4. "Corrupt practice" means the offering, giving, receiving, or solicting of any thing of value to influence the action of a public official in the procurement process or in contract execution.

#### 3 General

#### 4 Standards

- 4.1. The goods supplied shall conform to the standards mentioned in the bidding documents and spoofications
- 5 Use of contract documents and information; inspection.
- 5.1. The supplier shall not, without the purchaser's pnor written consent, diadosa the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shalf bo made in confidence and shall extend only so fail as may be necessary for purposes of such performance.
- 5.2 The supplier shall not without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.

#### 8 Patent rights

#### 7 Performance security

- 7.1. Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount spooffed in SCC.

- 21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the limit schedule prescribed by the purchaser in the contract.
- 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding limitly delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fext of the delay, its likely duration and its cause(s). As soon as practicable efter receipt of the supplier's notice, the purchaser shall evaluate the situation and may all his discretion extend the supplier's firm for performance, with or without the imposition of ponalties, in which case the extension shall be raiffied by the parties by amondment of contract.
- 21.5. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local sulbordy.
- 21.4. The right is reserved to proceed outside of the contract around quantilies or to have name essential sorvices executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.



- 21.5. Except as provided under GCC Clause 25, a delay by the supprer in the performance of its delivery obligations shall revide the supplied to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of regulation.
- 21.6. Upon any dotaly beyond the delivery period in the case of a supplies contract, the purchaser shall without canceling the contract, be entitled to curchase supplies of a similar quarity and up to the same quantity in substitution of the goods not succeed in conformity with the contract and to return any goods delivered (afer at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

#### 22 Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the porodist specified in the contract, the purchaser shall, without projudice to its other remedies under the contract, docuct from the contract price, as a persety, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. #### 23 Termination for default.

However, the supplier shall continue performance of the contract to the extent not terminated
- 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by pronibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4. If a purchaser intends imposing a restriction on a supplier or any porson associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the infonded penalty as not objected against and may impose it on the supplier.
- 23.5 Any restriction imposed on any porson by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
  - (i) If the name and address of the supplier and  $\ell$  or person restricted by the purchaser.
  - (ii) the date of commercement of the restriction
  - $\langle n \rangle$  the period of restriction; and
  - (v) the reasons for the restriction.
- These details will be loaded in the National Treasury's control distablished from persons prohibited from duing business with the public sector (23.7) If a court of law convicts a person of an offence as contemplated in sections 1.2 or 13 of the Freventian and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from duing business with the public sector for a period on these than five years and not more than 10 years. The National Treasury is empowered to determine the pend of restriction and each case will be deaft with on its own marks. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

#### 24 Anti-dumping and countervalling duties and rights

When, after the case of bid, provisional payments are required, or antidumping or countervalling duties are imposed, or the amount of a provisional payment or anti-dumping or countervalling right is increased in reapert of any dumped or substitized import, the State is not liable for any Amount so required or imposed, or for the amount of any such increase. When after the said cale, such a provisional payment is no longer recorded or any such anti-dumping or countervailing right is abusined, or where the amount of such provisional payment or any such right is abused, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other amount whichmay be due to him.

#### 25 Force Majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 12 and 23, the succiler shall not be habe for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majoure.
- 25.2. If a force majoure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations undor the continue as far as a reasonably practical, and shall sock all reasonable alternative means for performance not prevented by the force insighting event.





Description of Services. The Contractor shall provide a comprehensive Integrated Pest Management (IPM) Plan for the buildings and other areas specified herein.

The submitted Plan shall be in accordance with the District's IPM Policy. IPM is a process

for achieving long-term, environmentally sound pest suppression through the use of a wide

variety of technological and management practices. Control strategies in an IPM Plan

should extend beyond the application of pesticides to include structural and procedural

modifications that reduce the food, water, harborage, and access used by pests. The Contractor shall furnish all supervision, labor, materials, and equipment necessary to accomplish the surveillance, trapping, and pesticide application components.

of the IPM Plan. The Contractor shall also provide detailed, site-specific recommendations

for structural and procedural modifications necessary to achieve past prevention.

Pests Included and Excluded. The Contractor shall adequately suppress the following pests:

- Indeer populations of commensal rodents (e.g., Norway and roof rats, house mice), cockroaches, ants (including, but not limited to, fire ants and pharach ants\*), flies, spiders, and any other arthropod pests not specifically excluded from the contract.
- . Fopulations of the above pests that are located outside of the specified buildings, but within areas immediately adjacent to buildings.
- Winged termite swarmers emerging indoors.

Populations of the following pests are excluded from this contract:

- . Termites, carpenter ants and other wood-destroying organisms.
- . Moscuitoes.
- . Birds, bats, snakes, and all other vertebrates other than commensal rodents.
- Pests that primarily feed on outdoor vegetation.

### GENERAL CONTRACTOR RESPONSIBILITIES

**Initial Inspections of Facilities.** The Contractor shall conduct a thorough initial inspection of each building or site within \_\_\_\_ (10) days of the initiation date of the contract

Proposed Methods and Equipment for Service: The Contractor shall provide a summary of proposed control methods including current labels and Material Safety Data Sheefs (MSDS) of all pesticides to be used, brand names of pesticide application equipment, rodent balt boxes, insect and rodent trapping devices, pest monitoring devices, pest surveillance and detection equipment, and any other pest control devices or equipment that may be used to provide service.
- B. Proposed Methods for Monitoring and Surveillance: The Contractor shall describe methods and procedures to be used for identifying sites of pest harborage and access, and for making objective assessments of pest population levels throughout the term of the contract. In addition, the Contractor will work with the IPM Coordinator to establish population levels that constitute unacceptable levels of pest presence in school facilities.
- C. Service Schedule for Each Building of Site: The Contractor shall provide complete service schedules that include planned frequency of Contractor visits, specific day(s) of the week for Contractor visits, and approximate duration of each visit.
- Description of any Structural or Operational Change That Would Facilitate the Pest

Control Effort: The Contractor shall describe site-specific solutions for observed sources of pest food, water, harborage, and access.

E. Commercia! Applicator or Technician Licenses: The Contractor shall provide a current list of names along with photocopies of the commercial applicator or technician's licenses for every Contractor employee who will be performing on-site services under this contract.

Record Keeping. The Contractor shall be responsible for maintaining a pest control logbook or file for each building or site specified in this contract. These records

Pest Control Plan: A copy of the Contractor's approved Pest Control Plan for that facility, including labels and MSDS sheets for all pesticides used in the building, brand names of all pest control devices and equipment used in the building, and the Contractor's service schedule for the building.
- B. Service & Complaint Logs: A logbook for recording service visit activities, complaints from staff concerning pest observations or pesticide applications. Forms should show times in and out and should be signed by the Contractor at each service visit.
- C. Service Report Forms: Customer copies of the Contractor's Service Report Form, documenting all information on pesticide applications, pest sightings, sanitation/environmental status, and building maintenance needs. In addition, copies of the above-mentioned Service Report Forms should be forwarded by the Contractor to the IPM Coordinator at least once a month by the Contractor.

Times of Service. The Contractor shall perform routine pest control services only during times when STAFF are not expected to be present for normal activities for at least 12 hours after the application (as defined under Article 1358-6 ' 4J(e) of the

Structural Pest Control Act and Title 22, Texas Administrative Code, '595.11). In the event of a possible need for an emergency treatment, (as defined by Title 22, Texas Administrative Code, '595.8 (d) and '595.11) the Contractor shall work with the IPM Coordinator to determine whether an emergency situation exists before applying any posticides. In such cases posticides may be applied only to the local area of infestation if

\$TAFF are present or if less than 12 hours will elapse before students are expected to be

present. In the event of such an emergency treatment, the contractor will maintain records

of the reasons for such treatments for the period prescribed by law.

Health and Safety. The Contractor shall observe all safety precautions throughout the performance of this contract, and shall assume full responsibility and liability for compliance with all applicable regulations pertaining to the health and safety of personnel

during the execution of work, and shall hold the District harmless for any action on its

or that of its employees that results in litness, injury, or death.

Uniforms and Protective Clothing. All Contractor personnel working in or around buildings designated under this contract shall wear distinctive uniform clothing. The Contractor shall determine and provide additional personal protective equipment required.

for the safe performance of work. Protective clothing, equipment, and devices shall, as a

minimum, conform to Occupational Safety and Health Administration (OSHA) standards for

the products being used.

Vehicles. Vehicles used by the Contractor shall be identified in accordance with state and local regulations and shall be operated in a safe manner on HOSPITAL property.

Licensing. Throughout the term of this contract, the Contractor shall maintain a current business license issued by the Structural Pest Control Board. In addition, all Contractor personnel providing on-site pest control service must maintain licensing (In

categories appropriate to the work being performed) as commercial applicators or ficensed technicians. Unlicensed applicators will not be permitted to provide service to the

District under this contract.

Complaints. Should at any time the HOSPITAL become dissatisfied with pest control

service, the successful Contractor shall be notified in writing by the IPM Coordinator regarding problems that occurred. The notice will detail the problems and site(s) which is

experiencing the problems. The contractor will be required to contact the IPM Coordinator

to discuss possible solutions, and the contractor will be given a date by which a written

response with the proposed solutions must be submitted.

## . PEST CONTROL RESPONSIBILITIES

**Structural Modifications and Recommendations.** The Contractor shall be responsible for advising the IPM Coordinator about any structural, sanitary, or procedural

modifications that would reduce pest food, water, harborage, or access. The Contractor

shall be responsible for adequately suppressing all pests included in this contract regardless of whether or not the District implements suggested modifications. The District

 $\psi^{ij}$  not hold the Contractor responsible for carrying out structural modifications as gart of

the pest control effort. However, minor applications of caulk and other sealing materials by

the Contractor to eliminate pest harborage or access may be approved by the Distriction a

case-by-case basis. The Contractor shall obtain the approval of the IPM Coordinator prior

to any application of sealing material or other structural modification.

Use of Pesticides. The Contractor shall be responsible for application of pesticides according to the label. All pesticides used by the Contractor must be registered

with the U.S. Environmental Protection Agency (EPA) and by the State of Texas. Transport, handling, and use of all pesticides shall be in strict accordance with the manufacturer's label instructions and all applicable Federal, state and local laws and regulations.

The Contractor shall adhere to the following rules for pesticide selection and use: A. Non-pesticide Products and Their Use: The Contractor shall use non-pesticidal methods of control wherever possible. For example:

Portable vacuums rather than pesticide sprays shall be used for initial cleanouts of cockreach infestations, for swarming (winged) ants and termites, and fer control of spiders in webs wherever appropriate.

.(Trapping devices rather than pesticide sprays shall be used for indoor fly control wherever appropriate.

B. Application by Need: Pesticide application shall be according to need and not by schedule. As a general rule, application of pesticides in any inside or cutside area shall not occur unless visual inspections or monitoring devices indicate the presence of pests in that specific area. Preventive pesticide treatment of areas where surveillance indicates a potential insect or rodent infestation, are acceptable on a case-by-case basis, as approved by the IPM Coordinator.

C. Pesticide Products and Their Use: When it is determined that a pesticide must be used in order to obtain adequate control, the Contractor shall employ the least hazardous material, most precise application technique, and minimum quantity of pesticide necessary to achieve control.

When selecting pesticide products, highest priority shall be given to use of products on the Green and Yellow Lists, in that order, according to the criteria established in the most recent Structural Pest Control Board definitions of these products: Containerized and other types of crack and crevice-applied bait formulations, rather than sprays, shall be used for cockroach and ant control wherever appropriate.

As a general rule, liquid aerosoi, or dust formulations shall be applied only as

crack and crevice treatments with application devices specifically designed or modified for this purpose. "Crack and crevice treatment" is defined in this contract as an application of small amounts of insecticides into cracks and crevices in which insects hide or through which they may enter a building.

Application of pesticide liquid, aerosol, or dust to exposed surfaces, and pesticide space sprays (including fogs, mists, and ultra-low volume applications), shall be restricted to unique situations where no alternative measures are practical. The Contractor shall obtain the approval of the IPM Coordinator prior to any application of pesticide liquid, aerosol, or dust to exposed surfaces, or any space spray treatment. The Contractor shall take all necessary precautions to ensure student and staff safety, and all necessary steps to ensure the containment of the pesticide to the site of application.

- D. Pesticide Storage/Disposal: The Contractor shall not store, or dispose of, any
  pesticide production District property.
- E. Pesticide Sales and Distribution: The Contractor shall not seil, share, or make available any pesticide products to any non-licensed District employee.

Rodent Control. As a general rule, rodent control inside occupied buildings shall be accomplished with trapping devices. All such devices shall be concealed out of the

general view and in protected areas so as not to be affected by routine cleaning and other

operations. Trapping devices shall be checked on a schedule approved by the IPM Goordinator. Trapping shall not be performed during periods when maintenance will its

delayed by holidays, weekends, etc. The Contractor shall be responsible for disposing of

all trapped rodents and all rodent carcasses in an appropriate and timely manner. It circumstances when rodenticides are deemed essential for adequate rodent control inside occupied buildings, the Contractor shall obtain the approval of the IPM Coordinator prior to making any interior rodenticide treatment. All rodenticides, regardless

of packaging, shall be placed either in locations inaccessible to children, pets, wildlife, and

## BF 03 SAFETY REQUIREMENTS

No pesticide shall be used for any purpose other than that recommended on the manufacturer's label of the pesticide container. All warnings and precautions set out on the manufacturer's label shall be adhered to. The manufacturer's label shall never be removed from the container.

A Pest Control Operator shall be appointed by the Contractor and the relevant certification, as specified in sub-clause BE 08.03 below, shall be submitted to the Engineer before the first pesticide application.

The Pest Centrol Operator (PCO) will at all times ensure that pesticides are kept secure and out of reach of the general public. The PCO shall be responsible for the safe disposal of surplus pesticides as well as all empty pesticide containers.

The PCO will further ensure that no member of the general public is at any time in danger of being contaminated with the pesticide. Should a member of the general public be contaminated the PCO will immediately follow the first-aid and emergency treatment outlined in the standards.

## BF 04 INITIAL PEST CONTROL PROCEDURE

## BF 04.01 COMPILING OF A PEST CONTROL PROGRAMME

Sefore any pest control is to be administered the Contractor shall inspect the various buildings and installations at each facility and subsequently compile and submit a report, to the Engineer, detailing the comprehensive preventative pest control programme to be implemented.

The report submitted to the Engineer shall include but shall not be limited to the following:

- (a) The status of the pest infestation of the various buildings and installations at each facility.
- (b) The initial "clean up" procedure to be implemented.
- (c) The procedures of how to close off all entry points for rodents.
- (d) The routine monitoring and reporting procedures.
- (e) Estimated costs for the above.

## BF 04.02 <u>INITIAL "CLEAN UP" AND RODENT PROOFING</u>

The Contractor shall implement the initial "clean up" procedure and the rodent proofing of the various installations, as described in the pest control programme, buildings and only after instructions from the Engineer have been obtained.

## BF 05 MONITORING AND REPORTING OF PEST CONTROL STATUS

The status of pest infestation shall be monitored. The Contractor shall compile a report on the condition as well as recommendations at the intervals specified in the Particular Specifications. The report shall include but shall not be limited to the following details:

- (2) Report on the type and status of damage caused by pests.
- (b) Report on the visual observation of the presence of pests.
- (c) Report on the pest control monitoring results.
- (d) Report on the standing of the preventative pest control.
- (e) The recommended pest control procedure.

This report is to be submitted to the Engineer. Only upon instruction from the Engineer shall the recommended post control procedures be implemented.

if, at any intermediate period, the need for pest control should arise the Contractor shall submit a report and recommendations to the Engineer and await his instructions.

## BF 06 PREVENTATIVE PEST CONTROL

The Contractor shall administer preventative pest control as often as required but in accordance with the intervals specified by the manufacturer of the pesticide.

The Contractor shall report on the standing of pest activity and damage caused by the pests after each inspection as outlined in clauses PFE 02, PFE 03, PFE 04 and PFE 05 of Particular Specification PFE. The report is to be submitted to the Engineer (as in clause BF 05 above). The Contractor shall obtain the permission of the Engineer before any additional preventative pest control is to commence.

## BF 07 TRAINING OF EMPLOYER'S PERSONNEL

Pests are attracted to areas where food and water are in abundance. Good housekeeping techniques can improve the likelihood of keeping an area pest free. It is therefore essential to train the Employer's relevant personnel in the essential housekeeping techniques. The objectives of the training shall be to ensure that the following be achieved:

- (a) The identification of possible attractions for pests.
- (b) The elimination of waste disposal situations which may attract pests.
- (c) Reducing the overall cost of pest control by keeping the areas as clean and pest free as achievable.

The training course shall be in accordance to the Additional Specification SD: General Training and shall furthermore include at least the following:

- (a) The effective methods of waste disposal in order not to attract pests.
- (b) The effective methods of storing foodstuffs in order not to promote the nesting and infestation of pests.
- (a) Cleaning of facilities to avoid attracting posts.

The Contractor is to develop a training syllabus in accordance with Additional Specification SD: General Training. The training syllabus shall include but shall not be limited to the following information:

- (a) The effective methods of waste disposal in order not to attract pests.
- (b) The effective methods of storing foodstuffs in order not to promote the nesting and infestation of pests.
- (c) Cleaning of facilities to avoid attracting pests.
- (d) General information about the various pests which may be found at the facility.

## BF 08 LOGGING AND RECORDING

The Contractor shall institute a logging and recording system as part of his management control plan. This shall consist of a file containing the particulars as described in detail below:


## BF 08.01 PESTICIDE QUALITY

A sample of each batch of each type of pesticide used shall be taken and stored in a sealed clean glass container. The container shall be clearly marked. These samples are to be kept in safe and appropriate storage by the Contractor in case of a dispute arising from insufficient control of vermin or contamination of any sort.

## BF 08.02 LOGGING OF PESTICIDE APPLICATIONS

After each application of pesticides a Pesticide Application Log Sheet (Form PC-1, that forms part of this specification) is to be completed and submitted to the Engineer. The Pesticide Application Log Sheet (Form PC-1) includes the following details:

- Name of the pest control operator
- Name and address where the pesticide application was administered.
- Date of the pesticide application
- Manufacturer of the pesticide
- Pesticide name and active ingredient
- Batch identification of the posticide
- Formulation and concentration of the pesticide
- The pest and type of control aimed at
- Type of application i.e. residual spray, fumigant, bait etc
- Area of application.
- Quantity of product used
