



- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail. (if applicable) and will supplement the

Definitions
The following terms shall be interpreted as indicated:

- 12.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids




