GCC

NOTES

The purpose of this document is to:

- Oraw special attention to certain general conditions applicable to government bids, contracts and orders; and
- To ensure that clients be familiar with regard to the rights, and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural anid vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all Ibid/quotation documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific birl, should be compiled separately for every birl (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1. "Closing lime" means the date and hour specified in threi blidding documents for the receipt of bids.
- "Contract" means the written agreement entered into botween the purchaser and the supplier, as recorded in the contract form signed by the parties, 12 including all attachments and appendices thereto and all documents incorporated by reference therein.
- "Confract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations. 13
- "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement 1.4.

- "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligenes and not inreseeable. - "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among biddiers (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.


